WHEREAS, the County owns land located at 8707 88th Avenue, Pleasant Prairie, also known as parcel number 92-4-122-162-0100; and

WHEREAS, a portion of this land is used as the Kenosha County's paupers' cemetery; and

WHEREAS, another portion, beginning at a line running cross the entirety of the Subject Property from north to south 450 feet from the east property line and running eastward to the east property line, and consisting of approximately two acres of land (the "Subject Property"), is currently being worked by J & R Steinbrink Farms LLC for agricultural purposes pursuant to agreement with Kenosha County; and

WHEREAS, the Subject Property has no direct access, is landlocked, and is effectively worthless for any purpose other than its current use; and

WHEREAS, as such, the Subject Property is unlikely to have value beyond that attributable to it by the party currently working it; and

WHEREAS, the best opportunity to return the Subject Property to the tax rolls is to convey it to J & R Steinbrink Farms or its approved designee;

NOW THEREFORE, BE IT RESOLVED that the Kenosha County Board of Supervisors approves the transfer of the Subject Property to J & R Steinbrink Farms or its approved designee; and

BE IT FURTHER RESOLVED that the administration is authorized to complete any and all actions necessary to carry out this transfer.

WHEREAS, the County is designing a shared use path to be constructed on the south side of County Trunk Highway C from $114^{\rm th}$ Avenue to Bain Station Road in the Village of Pleasant Prairie. The construction of the shared use path is part of a proposed improvement that is recommended in the Kenosha County Comprehensive Bike Plan; and

WHEREAS, the proposed shared use path cuts across the northern section of a County property, parcel 11, highlighted on the attached right-of-way plat. The Federal Highway Administration (FHWA) land acquisition guidelines require that the impacted section of parcel 11 be acquired by a County right-of-way dedication for the construction of the shared use path; and

WHEREAS, the Highway Commissioner has reviewed the FHWA requirements and determined that the said dedication is necessary and essential for the construction of the County Trunk Highway C shared use path; and

NOW, THEREFORE BE IT RESOLVED, that Kenosha County Board of Supervisors approves the dedication of Right-Of-Way of a section of Parcel 11 as highlighted on the attached Plat of Right of Way, No: 3736-06-00 for the construction of the proposed shared use path.


