



WHEREAS, the American Transmission Company (ATC) is currently constructing the “Spring Valley-North Lake Geneva Electric Reliability Project”, and

WHEREAS, sections of the power transmission lines for this project run through western Kenosha County, and

WHEREAS, two parcels of property owned by Kenosha County are affected by this project, in that electrical power lines will run over these two parcels, requiring the County to grant an easement to ATC for the installation and maintenance of said overhead lines, and

WHEREAS, the first affected parcel is identified as #95-4-119-014-1025, described as Lots 6 and 7 in Block 1 of Oakwood Shores Third Addition being part of Section 1, Town 1 North, Range 19 East, in the Town of Wheatland, County of Kenosha, State of Wisconsin (see attached map), and

WHEREAS, the second parcel is identified as #70-4-120-102-0303, described as Part of the Northwest Quarter of Section 10, Town 1 North, Range 20 East of the Fourth Principal Meridian, lying and being in the Village of Salem Lakes, County of Kenosha, State of Wisconsin (see attached map), and

WHEREAS, ATC is requesting Kenosha County grant a permanent easement to access these parcels as necessary for the construction and maintenance of overhead power-lines, and

WHEREAS, ATC is offering a sum of \$2,400 to acquire an easement that permits power-line construction/maintenance and offset the estimated cost of diminution of property value on parcel #95-4-119-014-1025, and \$2,100 for like easement and diminution of property value on parcel #70-4-120-102-0303,

NOW, THEREFORE BE IT RESOLVED that the Kenosha County Board of Supervisors approves the easements under the terms described in this resolution, and

BE IT FURTHER RESOLVED that the Kenosha County Board of Supervisors authorizes the Director of Public Works and Development Services to execute any contracts, agreements or other documents necessary to complete these transactions.

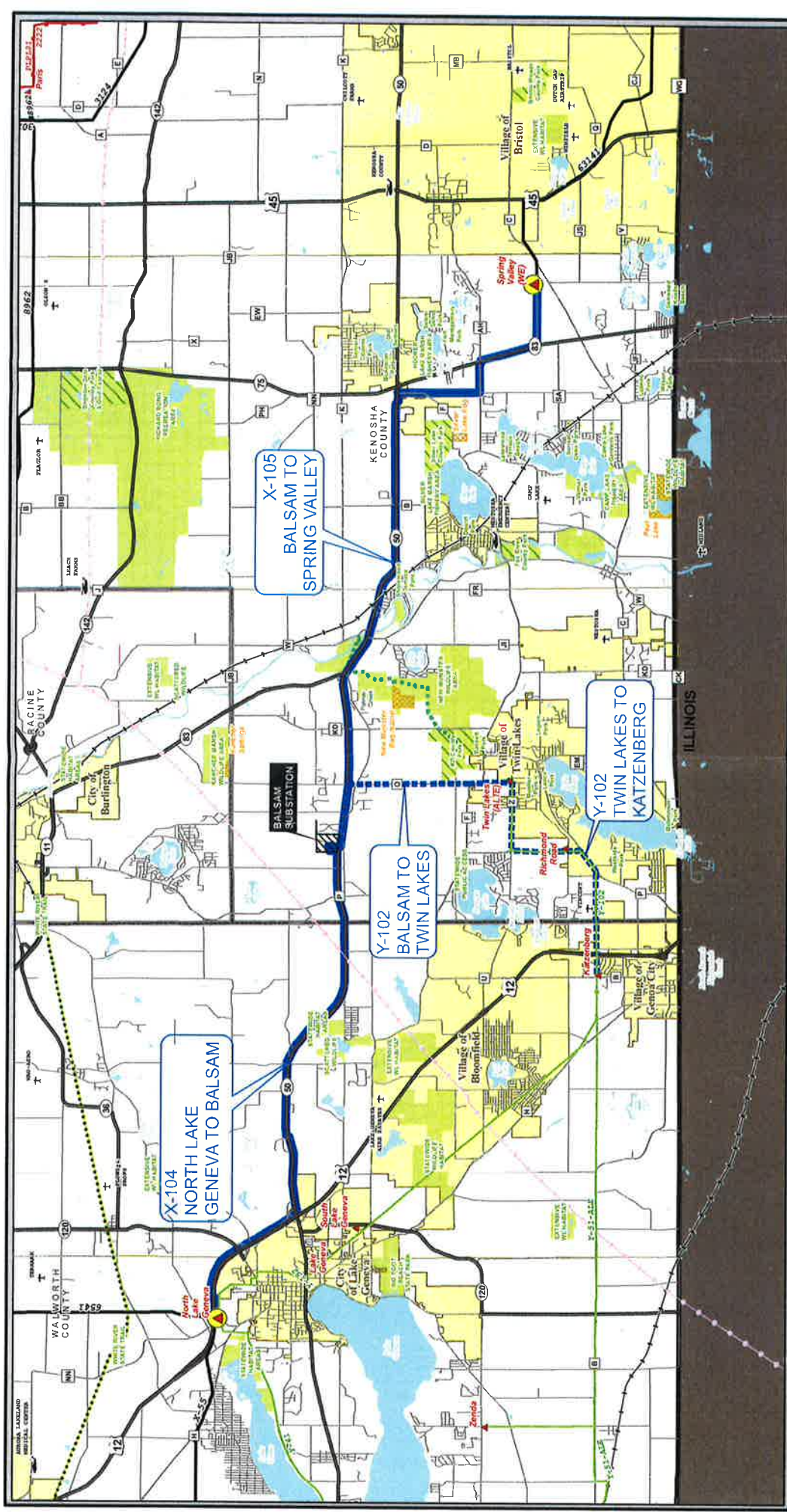

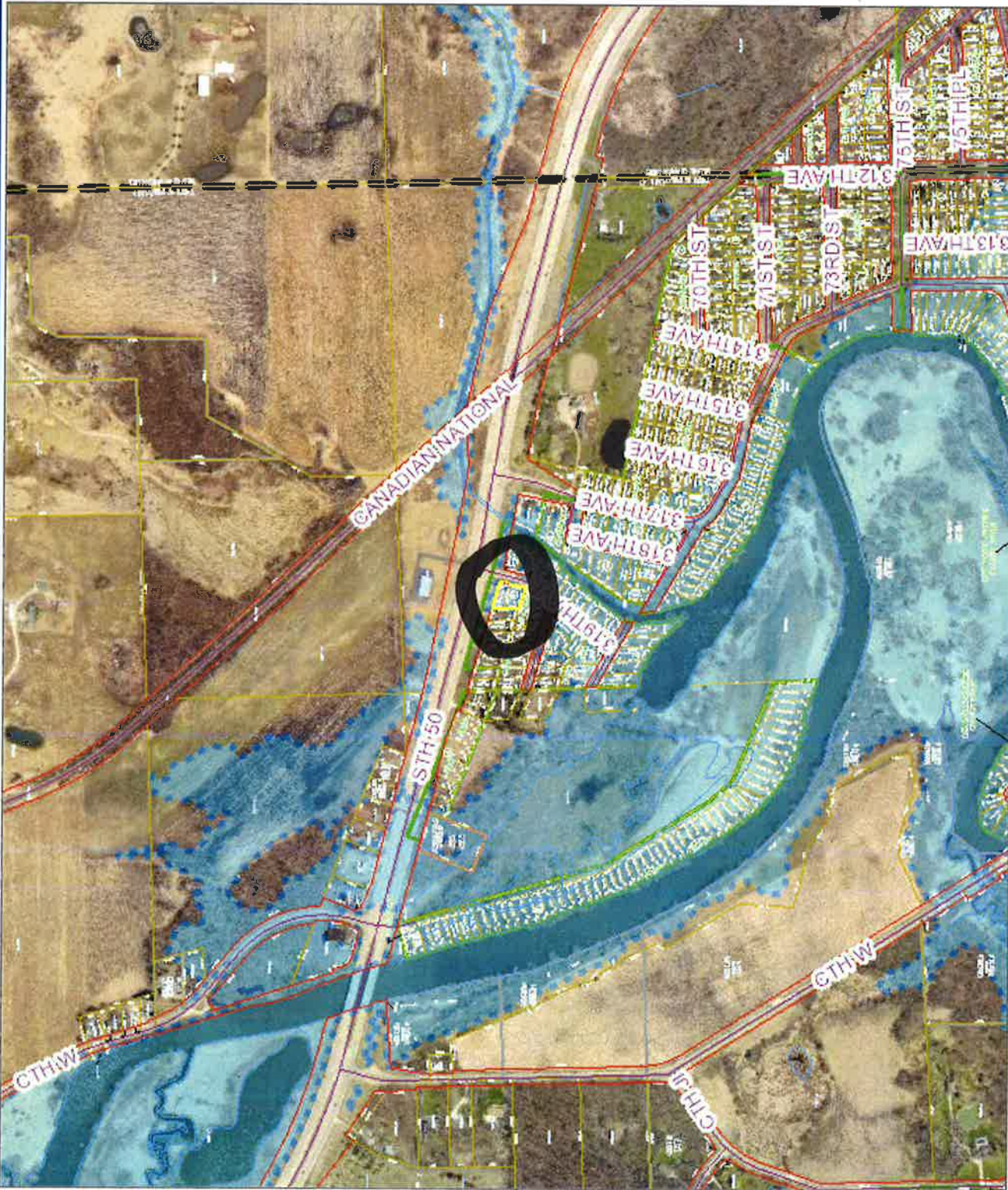

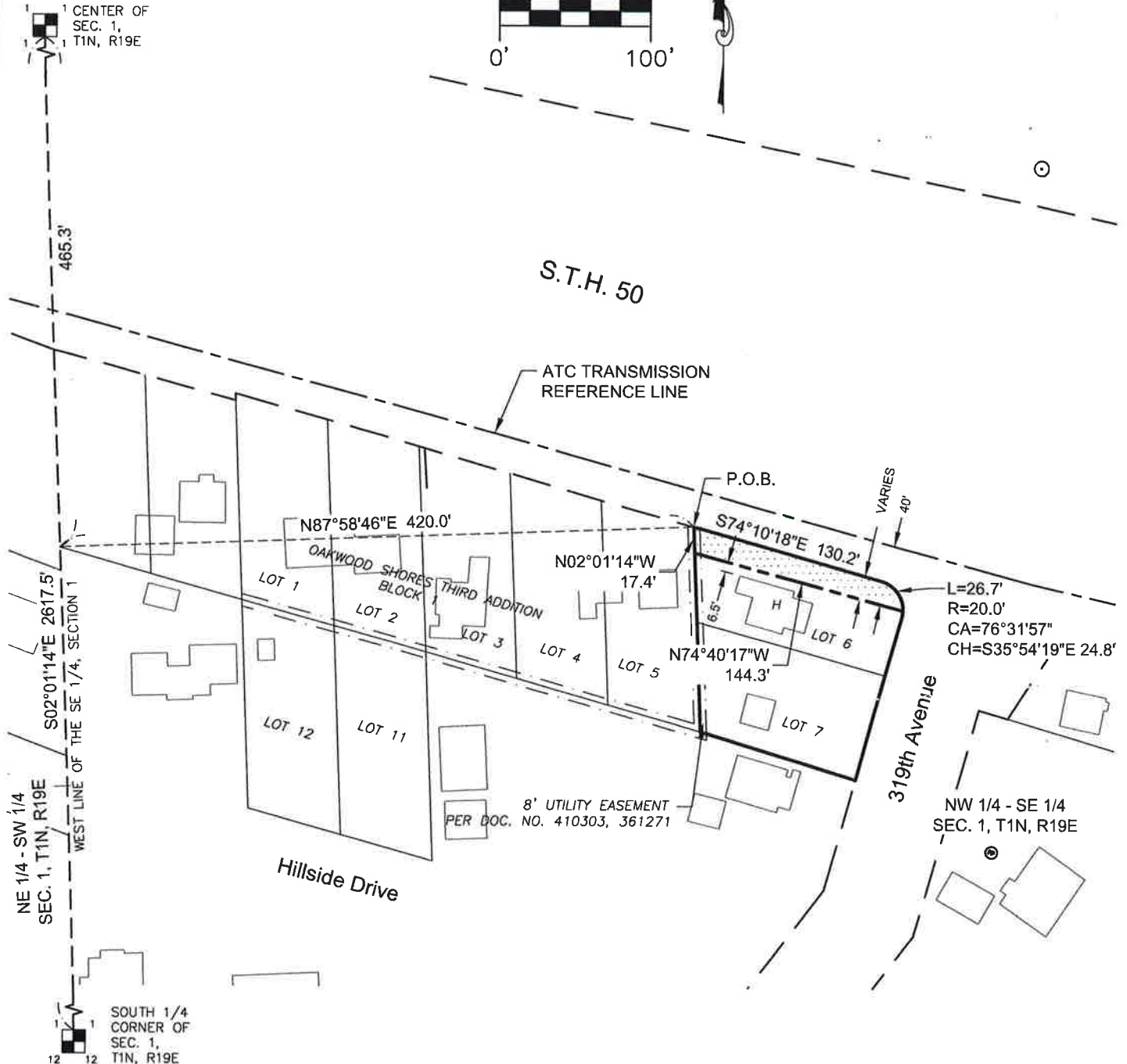


ATC TRANSMISSION LINE EASEMENT

EASEMENT DESCRIPTION (EXHIBIT B)

A variable width easement which crosses a part of the grantor's premises, being a part Lot 6 in Block 1 of OAKWOOD SHORES THIRD ADDITION plat as recorded with the Kenosha County Register of Deeds as document number 308788, located in the Northwest Quarter of the Southeast Quarter of Section 1, in Township 1 North, Range 19 East, in the Town of Wheatland, Kenosha County, Wisconsin, more fully described as follows:

Commencing at the Center of said Section 1; thence South 02°01'14" East along the west line of said Southeast Quarter, 465.3 feet; thence North 87°58'46" East, 420.0 feet to northwest corner of said Lot 6 and the south right of way line of State Trunk Highway 50 also being the **Point of Beginning**; thence **South 74°10'18" East** along said south right of way line, **130.2 feet** to a point of curvature; thence southeasterly **26.7 feet** along the arc of a curve to the right also being said south right-of-way line of State Trunk Highway 50 and the west right-of-way line of 319th Avenue, with a radius of **20.0 feet**, through a central angle of **76°31'57"**, and a chord that bears **South 35°54'19" East, 24.8 feet**; thence **North 74°40'17" West, 144.3 feet** to the west line of said Lot 6 also being the west property line of the grantor; thence **North 02°01'14" West** along said west lines, **17.4 feet** to the **Point of Beginning**; Containing **2,270 square feet (0.052 acres)** more or less and subject to restrictions, reservations, rights of way and easements of record.

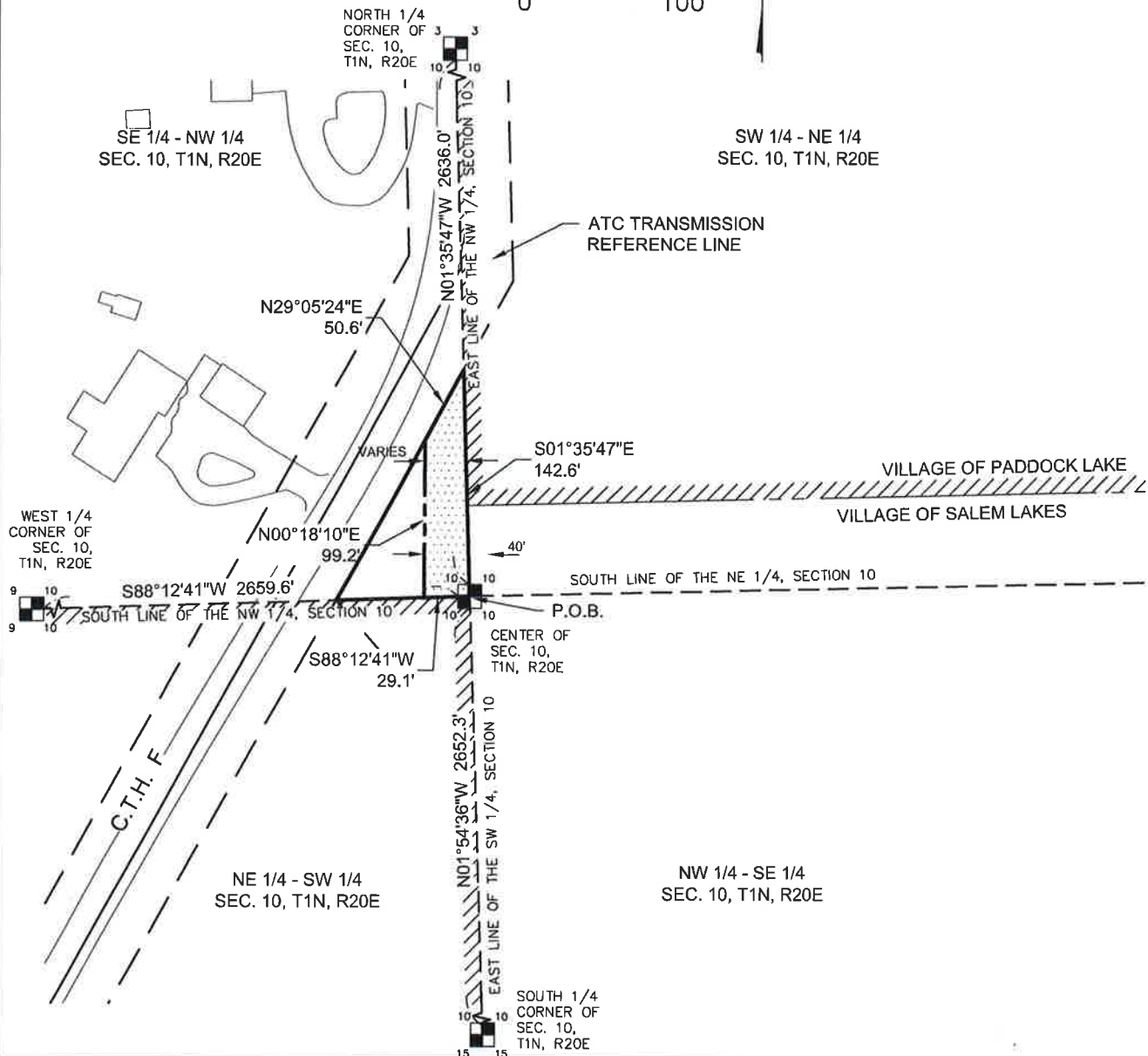
