I was driving northbound on 288th St. at 4:00pm on 01/15/2024 and as i was driving i saw a Kenosha County
Snow Plow truck traveling southbound on 288th St. towards me. He wasnt plowing but he was salting the roads
with a brownish salt. As we were about to pass eachother i saw a big chunk of salt come out of his spreader
(roughly about the size of a football) tumble across the road and get kicked up and hit and cracked my windshield.
i immediately pulled over and called Kenosha County PD, Officer #387 came out and assessed the damage to my
car and wrote out an incident report #24-302051. My witness was the car behind me and he saw the whole thing
happen and his vehicle was even struck by the salt that struck my car, but fortunately his vehicle was not damaged.
he pulled over behind me when i was struck but assessed his vehicle and determined his vehicle was not damaged
and eventually left the scene before Officer #387 arrived.

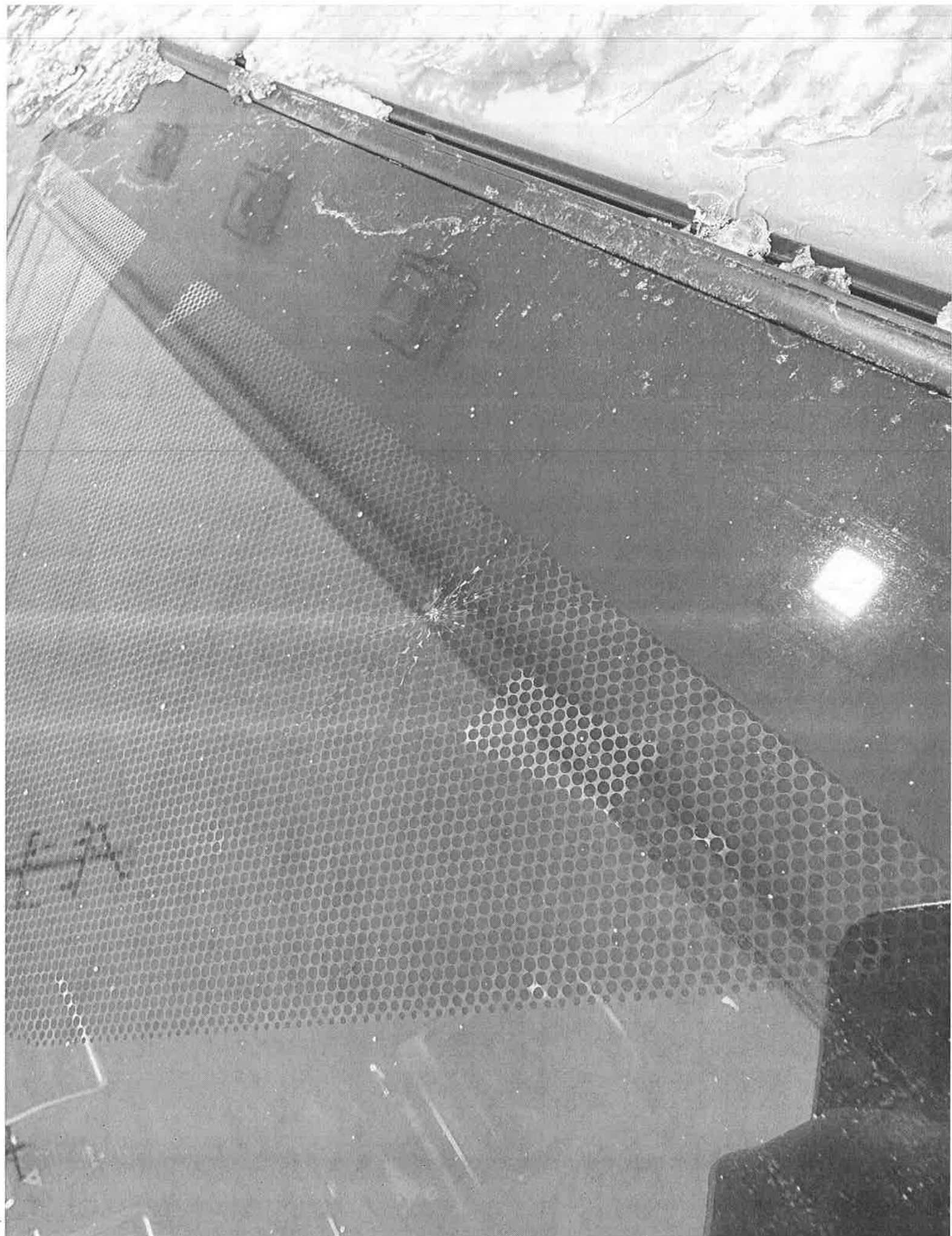

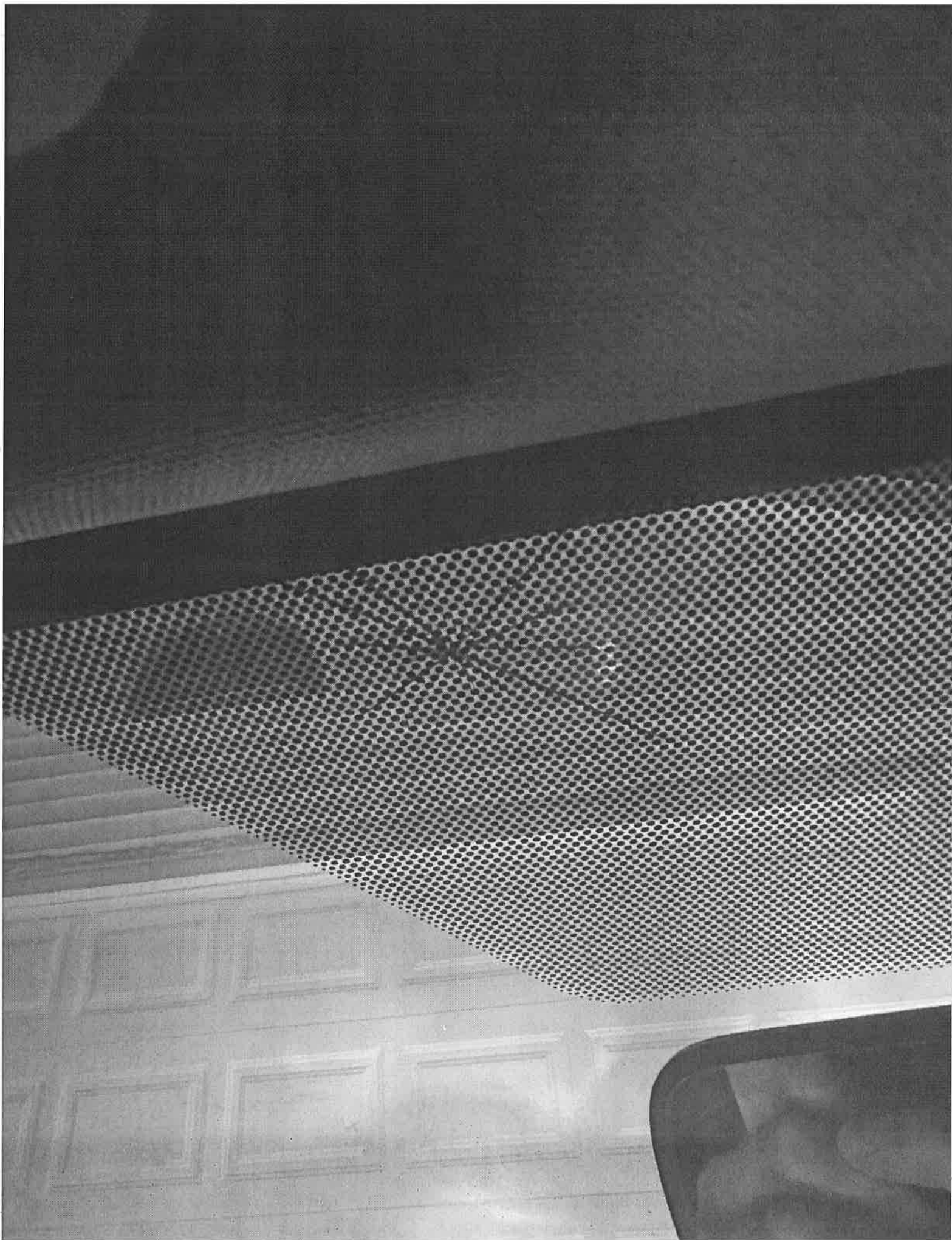

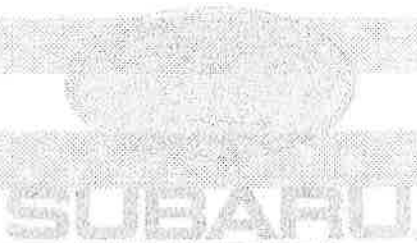
