Mr. Riedl stated that per the current policy there are in fact many steps that the County takes before terminating employees and that these are outlined in the current policy. He added that the termination cases are brought before an independent legal hearing officer, as well as County management including the County Executive before a motion is made to terminate. Supervisor Gentz asked if the Committee had the right within the current policy to have more input. Mr. Riedl replied no the policy would have to be changed through resolution. Supervisor Dodge stated he may bring a resolution at a later date for formal action to take place regarding this matter.
