A. 12.27-6(d): that all detached accessory structures shall be located in the side or rear yard in the R-2 Suburban Single-Family Residential Dist.) to construct a detached garage to be located in the street yard (side or rear yard required) on Tax Parcel #60-4-119-182-0500, Town of Randall.

- Ms. Ford made a motion to <u>remove from the table</u> the temporary use permit request of Clem Stein III to temporarily operate an agricultural tourism/event barn in the A-2

General Agricultural Dist. & C-2 Upland Resource Conservancy Dist. on Tax Parcel # 95-4-119-024-0300 & 95-4-119-023-0200.
