Minutes of the Kenosha County Planning, Development & Extension Education Committee public hearing held on Wednesday, October 11, 2017 at 6:00 p.m. in the Kenosha County Center Public Hearing Room, 19600 -75th Street, Bristol, Wisconsin.

The meeting was called to order at 6:00 p.m. by Chairman Decker.

1. **Certification of Compliance with Wisconsin Open Meetings Law:** The committee confirmed that all requirements of the Wisconsin Open Meetings Law had been met.

Citizen Comments was moved up on the agenda per a request from the audience.

2. **CITIZEN COMMENTS**

Donna Zarovy, 6207 203rd Avenue, Bristol, noted that she was a recent retiree of the UW Extension office, having served for 24 years. She spoke in support of continued full staffing of the Kenosha County UW Extension office in light of the nEXT Generation reorganization of the UW-Extension system at large. She noted the community assistance offered by the office with 4-H, youth, community development, horticulture, and many other programs. She noted that she had received direct assistance with the Home and Community Educators (HCE) program from the former director Tedi Winnett and now with Bev Baker the new Area Extension Director.

3. Review and recommendation to the Finance Committee regarding the proposed 2018 UW-Extension budget(s):

Chairman Decker noted that Supervisor Skalitzky was unable to attend this evening because he was attending the Judiciary, & Law Enforcement Committee meeting that

was double-booked for this evening. Supervisor Skalitzky is a member of both committees. Supervisor Skalitzky requested that the budget review be rescheduled to allow him to attend for the discussion.

Chairwoman Breunig noted that Supervisor Skalitzky would have the opportunity to listen to the audio recording of the discussion and that he may offer comment at the Finance & Administration Committee public hearing October 25th. She urged the committee to allow the presentation since a number of staff were present to do so.

Supervisor Gillmore noted that she was not comfortable proceeding given that Supervisor Bostrom was also not in attendance at this time; Supervisor Poole concurred.
