NOW, THEREFORE BE IT RESOLVED, that the request for a probationary cabaret license be granted due to no serious incidents occurring at the tavern since August $8^{\rm th}$.

BE IT FURTHER RESOLVED, that the probationary cabaret license for El Fracazo Tavern may be withdrawn if any acts of violence occur at the tavern.

NOW, THEREFORE BE IT RESOLVED, that this reapplication by the license holder, Salomon Hernandez, be granted for a probationary period of nine months for the El Fracazo Tavern.

84. From Judiciary and Law and Finance Committees Recognizing Unanticipated Revenue Surplus to fund Overtime, Food/Grocery and Capital Budgets.

WHEREAS, the County of Kenosha did establish in the 2007 Sheriff's Department Budget a revenue line item for housing federal inmates of \$3,474,850 anticipating housing 127 per day, and

WHEREAS, based upon the realized daily average of 167 federal inmates at a reimbursement rate of \$70.00 per day plus transportation costs, the Sheriff's Department has unanticipated revenue through October and the outlook is favorable through year end, and

WHEREAS, department overtime expense, primarily for the Detentions and Patrol divisions, were forecasted through year end along with the Food budget, requiring an increase in Overtime and Retirement budgets by \$603,207 and the Food budget by \$40,000, and

WHEREAS, the integrated touchscreen Master Control Security System malfunctioned in early October causing a jail security shutdown for the Public Safety Building and the PreTrial Facility, and

WHEREAS, the recommendation of our security system contractor is to consider funding a project to improve the system before a major failure occurs that could shut the security system down for weeks, and

WHEREAS, the program re-write or replacement software could cost upwards of \$100,000.

NOW, THEREFORE BE IT RESOLVED, that the Kenosha County Board of Supervisors accept the attached budget modification , which is incorporated herein by reference, to recognize a portion of the expected surplus in Federal Inmate Housing revenue of \$743,207 and increase personnel costs, Food/Groceries and Capital budget totaling \$743,207.
