She also referenced the memo sent by Personnel that lists employees' paid holidays; nowhere on that schedule does it say that Correctional Officers do not get paid.

Proposed Amendment to Kenosha County Ordinance 3.60:

Motion by: Frederick Seconded by: A. Johnson Approved: unanimously 6:34: Jennifer Kopp, from the Office of the Corporation Counsel, presented the proposed amendment. She stated that this amendment updates statutory references. In the past, the "State of Wisconsin Traffic Deposit Schedule" was scanned and manually inserted into the Ordinance. The modified version will take this out and instead include reference to the Schedule, as amended from time to time, and include a link to the State of Wisconsin's website. They have also updated the cash deposits relating to Kenosha County's Ordinances. Supr. Montemurro asked when the last revision was done. Kopp replied in April 2012. Supr. Arrington stated that this basically makes the ordinance flow more user-friendly and asked if the State does revisions. Kopp replied that yes the State does revisions, however, sometimes not consistently. Supr. Noble referenced unclear language such as the passing of school busses. He asked if this is all cleaned up. Kopp stated that they have made sure that each section of the ordinance is up to date. They have modified verbiage to be consistent between the ordinance and State Statutes. Montemurro asked if the packets presented to Committee Members include all 2012 updates. Kopp replied yes.
