#### SUPERVISOR REPORTS

Supervisor Elverman stated the 60<sup>th</sup> St tower is up and they're looking at completion by the end of March. The bids for the Administration Building restoration are in and the lowest is about \$300,000 less than their estimates. The work is scheduled to begin March 31. The Highway Department is deeply into their 2 year supply of salt. The State has issued new guidelines for the State Highways; they will now use about 1/3 of the materials they would use on a normal run. They are mixing the salt with sand on the county roads. Golf has been very active. They were at the Golf Show in Chicago and will be going to Milwaukee's soon. They did very well as far as interest. All the Golf Leagues at Pets are sold and they are almost all sold at Brighton Dale as well.

Supervisor Dodgetated he went to the Veterans Service Office for a meeting. He thanked the Administration and the County Board for their support of the County's Veterans Service Commission. For the past two years he has attended meetings and sees firsthand how they help the veterans in distress. He asked for the board's continued support in the budgets ahead for this worthy cause.

## **RESOLUTION 107**

107. From Public Works/Facilities Committee a Resolution to support a proposed Kenosha County Wide Bicycle Route and Guide Signing project in the Wisconsin Department of Transportation 2014-2018 Transportation Alternatives Program.

**WHEREAS**, the Comprehensive Bike Plan for Kenosha County 2025 recommends a countywide transportation network for use to destinations such as work, commercial businesses and recreational opportunities, and

**WHEREAS**, the plan includes key short term projects the highest priority being the installation of signs along existing bicycle routes as a clear and direct navigational aid across the County, and

**WHEREAS**, bikeway signing throughout the County will provide guidance to bicyclist and will also provide a visual cue to motorists that they are driving along a bicycle route and should use caution, and

WHEREAS, Kenosha County has submitted an application for funding in the Wisconsin Department of Transportation 2014-2018 Transportation Alternatives Program which involves the installation of bicycle route and guide signs along designated routes and the signs will include Mobile Aware technology that can be accessed via a smart phone to a web based site that will provide information to the cyclist such as detailed mapping, distance to along route, location of recreational opportunities such as parks, nearby businesses such as restaurants or other destinations of interest, and

**WHEREAS**, Kenosha County's application for funding in the Wisconsin Department of Transportation 2014-2018 Transportation Alternatives Program first round process has been approved and the second round of the application approval process requires a local resolution of support for the proposed project by the Kenosha County Board of Supervisors.

**NOW, THEREFORE, BE IT HEREBY RESOLVED** That the Kenosha County Board of Supervisors hereby supports the proposed Kenosha County Wide Bicycle Route and Guide Signing Project in the Wisconsin Department of Transportation 2014-2018 Transportation Alternatives Program.
