Following a major disaster, fire, police and other first responders may not be able to immediately reach all people who need help. The CERT program prepares people to respond to emergencies in their communities.

CERT training promotes a partnership between emergency services and the people they serve. Emergency personnel train individuals, neighborhoods, community organizations, or workplaces in basic response skills.

Session I, DISASTER PREPAREDNESS: Addresses hazards to which people are vulnerable in their business. Materials cover actions that participants and their co-workers take before, during, and after a disaster. As the session progresses, the attendees begin to explore an expanded response role giving them the tools to operate in a safe and appropriate manner. The CERT concept and organization are discussed as well as applicable laws governing volunteers in that jurisdiction.

Session II, STANDARDS: NFPA/OSHA standards, basic regulations that cover your business, including fire drills, emergency meeting places, mitigation for your business. Fire alarms. Offsite support and business continuity.

Session III, DISASTER FIRE SUPPRESSION: Briefly covers fire chemistry, hazardous materials, fire hazards, and fire suppression strategies. However, the thrust of this session is the safe use of fire extinguishers, sizing up the situation, controlling utilities, <u>and extinguishing a small fire</u>.

Session III, DISASTER MEDICAL OPERATIONS PART I: Participants practice airway obstruction, bleeding, and shock by using simple triage and rapid treatment techniques.

Session IV, DISASTER MEDICAL OPERATIONS, PART II: Covers evaluating patients by doing a head to toe assessment, establishing a medical treatment area, performing basic first aid, and practicing in a safe and sanitary manner.

Session V, SECURITY LAW: A summary of policy's and case law. A sample/template is provided. Liability in the business setting. Training responsibilities in a business setting.

Session VI, LIGHT SEARCH AND RESCUE OPERATIONS: Participants learn about search and rescue planning, size-up, search techniques, rescue techniques, and most important, rescuer safety. Safety FIRST!

Session VII, DISASTER PSYCHOLOGY AND TEAM ORGANIZATION: Covers signs and symptoms that might be experienced by the disaster victim and worker. It addresses CERT organization and management principles and the need for documentation. ICS/NIMS level one and two summarized.

Session VIII, OTHER SAFE GUARDS: Crime Prevention Though Environmental Design, Active Shooter, Burglar alarms, CCTV, Fire Alarms. How electronics can save and enhance your security and Safety. Case law.

Session IV, COURSE REVIEW AND <u>DISASTER SIMULATION</u>: Finally, practice the skills that you have learned during the previous eight units in disaster activity.
