NEW BUSINESS

Resolutions - one reading

49. From Planning, Development & Extension Education Committee regarding proposed adoption of the Pike River Watershed-Based Plan as a guide for regional and community water quality management within the Pike River Watershed.

WHEREAS, Applied Ecological Services, under contract with the Root-Pike Watershed Initiative Network, was given the function duty of creating a watershed-based plan for the Pike River watershed; and

WHEREAS, a Pike River Advisory Group was formed, consisting of county and public officials, professionals and citizens from concerned parties within the Pike River watershed to assist Applied Ecological Services with the facilitation of the watershed- based plan creation; and

WHEREAS, the County of Kenosha has supported, participated in, and generally concurred with the regional planning and formulation of the Plan undertaken by Applied Ecological Services, and believes that the Pike River Watershed-Based Plan prepared by Applied Ecological Services is a sound and valuable guide to water quality management in the Pike River watershed, and the adoption of such plan by the County of Kenosha will assure a common understanding by the parties and agencies of government concerned and enable these parties and agencies of government to program the necessary plan implementation work; and

WHEREAS, the Environmental Protection Agency has officially recognized the Pike River Watershed-Based Plan as meetings all of its required planning elements; and

WHEREAS, the Town Board of the Town of Somers held a public hearing on April 22, 2014, and unanimously adopted of the Pike River Watershed-Based Plan; and

WHEREAS, the Kenosha County Planning, Development and Extension Education Committee held a public hearing on the request on August 13, 2014, and recommended adoption of the Pike River Watershed-Based Plan.

NOW, THEREFORE BE IT RESOLVED that the Kenosha County Board of Supervisors hereby adopts the Pike River Watershed-Based Plan as a guide for regional and community water quality management within the Pike River watershed.
