- Our new Lab Manager, Ana Brinkman, has been introduced.
- Kira Krause, Clinical Services/CD Team Leader, will be moving to the Wisconsin Well Woman grant position.
- Nurse Family Partnership has a new nurse, Samantha Ness, who started today.
- Sarah Milkie, previously in the Well Woman Program, will be moving to the Parents as Teachers (PAT) program.
- New School Nurse, MeShawn Gardner, started today.
- Our Medication Assisted Treatment Program is expanding to add a third nurse. We will also be adding a Public Health Tech position to this program who will also assist the Lab.
- Currently 3 open positions: Clinical Services/CD Team Leader; HUD Administrative Assistant, and Public Health Tech.

The Narcan Program has been receiving wonderful National recognition. We've distributed over 358 kits in the community.

The WIC office has several billboards throughout the community promoting their programs.

Will be preparing for Public Health Re-accreditation as this will occur between October and December.

Healthy People Kenosha County 2020 is one of the pillars of accreditation. We're in the process of assessing the future direction for the next 5 - 10 year cycle.

Kenosha Lifecourse Initiative will be meeting with the grant funders to determine the next steps of the grant.

Of our 69 health positions, 39 have been hired in the last 5 years. This is definitely the current trend: people moving, shifting jobs, turnover, orientation, onboarding and new hires for additional programs.
