Healthy People Kenosha County (HPKC)

Our Community Health Improvement Plan (CHIP) cycle ends in 2020. Looking for a facilitator to run the community focus groups using the 2016 data of our community health assessment to build and develop our new community health improvement plan. Undecided as to whether this will be a 5 or 10 year program.

Kenosha Lifecourse Initiative (KLIHF)

Scheduled to meet with the funders. As this grant ends April 2019, will be talking with the Wisconsin Partnership Program to determine next steps for this funding cycle.

Staffing

- Three open positions: Clinical Services Team Leader, HUD Administrative Assistant and Public Health Tech.
- Currently have 2 staff on long term medical leave.

Question asked as to our confirmed flu count. We only track hospitalizations so the number is very fluid. DHS does a weekly summary by state/region/county with numbers being found online.
