## Resolution from the Kenosha Co. Sheriff's Department:

1) Probationary Cabaret License – The Sly Fox Inn

Motion by: Haas Seconded by: Roger Johnson Approved: unanimously Lt. Falduto presented the resolution. Art & Jeri Hallenberg from Sly fox attended the meeting. Since the beginning of the year there have been only two violations. One was for underage drinking but the offender had a fake ID. During the initial inspection there was no licensed bartender on site and the business was cited. Subsequent checks found a licensed bartender on site. Art Hallenberg explained that his nephew, Romano, is the true owner, however, the license is in Hallenberg's name. Huff asked for an explanation as to why a licensed bartender was not on site. Hallenberg replied that most likely someone did not show up.

## Memo from the Sheriff's Department Regarding Disposal of County Property more than \$1,000 and less than \$10,000:

Lt. Falduto explained that this went to Finance and was approved. This is courtesy information presented because the Sheriff's Dept. likes to keep this Committee informed. They were able to purchase a new truck so these two (1984 Chevy Truck & 1986 Chevy Truck) are no longer needed and being sent to auction. This does not need to be approved by Judiciary & Law.

## Resolution from the Office of the Corporation Counsel and Supervisor William Michel II:

1) An Ordinance to Amend Chapter 9 of the Municipal Code of Kenosha County Entitled Public Peace and Good Order
