1. **TOWN OF BRISTOL**, PO Box 187, Bristol, WI 53104-0187 (Owner), requesting a temporary use to temporarily use a **field and an adjoining town hall parking lot to operate a farmers market** in the M-1 Limited Manufacturing District, PR-1 Park-Recreational District and B-3 Highway Business District on Tax Parcels # 35-4-121-083-0302 & 35-4-121-083-0300 located in the Town of Bristol.
