
PLANNING AND DEVELOPMENT ONLINE PERMIT AND INFORMATION PORTAL IS LIVE!

In 2011, the Kenosha County Division of Planning and Development adopted new software to digitally manage records for properties within Kenosha County. All record documentation has been stored digitally and all historical data created prior to 2011 has been scanned in preparation to be migrated into the database. Recently, the on-line portal went live and is now accessible to the public at https://permitting.kenoshacounty.org/eTrakit/.

The site will allow users to search public records and view basic permit, project, and case information within the unincorporated townships of Kenosha County, the Village of Salem Lakes, and the Village of Somers. In addition, the site will enable contractors to digitally submit and pay online for certain planning and development-related applications. Other features include:

- The ability to search for zoning permits, sanitary permits, shoreland permits, and storm water permits; see application dates, approved dates and issued dates for permits; and access to a basic description of the project including site location, contact information, and applicable fees.
- Search for public hearing applications including comprehensive land use plan map amendment applications, rezoning applications, variance applications, conditional use permit applications, temporary use permit applications, subdivision plat applications and certified survey map applications.
- Search for sanitary, zoning, shoreland and storm water complaints/violations; and access to a basic description of the complaint or violation, site location, and status.

FLOOD MAPS

What is a flood map?

The Federal Emergency Management Agency (FEMA) works with communities across the country to identify flood hazards

and promote ways to reduce the impact of those and other hazards. Flood maps are used for floodplain management, flood insurance rating, and to determine flood insurance requirements.

Flood maps generally show a community's flood zones, floodplain boundaries, and Base Flood Elevation; together they show the risk of flooding.

No matter where you live or work, some risk of flooding exists. To find your community's flood map, visit the FEMA Flood Map Service Center, then type in your address and search. You may view, print and download flood maps, open an interactive flood map (if available), and view all products related to your community.

A Flood Map:

- Also known as a Flood Insurance Rate Map (FIRM)
- Communicates flood risk to a community and its residents
- Informs local floodplain management regulations
- Identifies flood insurance risk zones called Special Flood Hazard Areas (SFHA)
- Determines insurance rates and the need to purchase insurance through the National Flood Insurance Program (NFIP)
- · Sets minimum floodplain standards and building standards for the community
- Is modified when there are changes in population growth and development, and improved science including changes in climate and weather patterns

Why do flood maps change?

Flood hazards change over time. How water flows and drains can change due to new land use and community development or by natural forces such as changing weather, terrain changes, or wildfires. To better reflect the current flood risk conditions, FEMA uses the latest technology to update and issue new flood maps nationwide to aid communities, property owners, businesses, and other stakeholders in taking steps to address flood risks.

KENOSHA COUNTY PROPERTY INQUIRY

The Kenosha County Property Inquiry application contains a vast amount of property-related data and is freely available on the Kenosha County website. Available information includes:

- Property ownership
- Address (property & mailing)
- Tax information
- Assessment information
- Building information
- Recorded documents
- Link to GIS mapping

Users can search for the above information by using parcel number, property address, or common location. Please note that search by owner name is not permitted due to privacy concerns. Additionally, personal property account records are also available for viewing. Various reports can be generated from the application and include:

- Property summary report
- Tax bills (current & historic)
- Tax balance report


