WHEREAS, the Kenosha County Clerk of Circuit Court employs several methods of collection included but not limited to income assignments, payment hearings, payments plans, judgment and tax refund intercept; and

WHEREAS, Wis. Stat. § 59.40(4) allows the Clerk of Circuit Court, if authorized by the Count Board under Wis. Stat. § 59.52(28), to contract with the Wisconsin Department of Revenue (DOR) for the collection of unpaid debt; and

WHEREAS, any agreement entered into with the DOR shall indicate that any collection fees incurred by DOR shall be in addition to the debt owed the Clerk of Circuit Court and charged by the DOR directly to the debtor; and

WHEREAS, the proceeds received by the Clerk of Circuit Court from the DOR shall be the entire amount of debt collected for purposes of distribution:

NOW, THEREFORE, BE IT RESOLVED by the Kenosha County Board of Supervisors that the Board hereby authorizes the Clerk of Circuit Court to contract with the DOR for the collection of unpaid debt pursuant to Wisconsin Statutes.

BE IT FURTHER RESOLVED that the County Board Chairperson and County Clerk are authorized to execute a contract to effectuate this purpose, subject to the review and approval of County Corporation Counsel.
