## **GUIDELINES FOR “CITIZEN COMMENTS” AT KENOSHA COUNTY BOARD AND COMMITTEE MEETINGS**

Please follow the guidelines for participating in Citizen Comments:

- Any person who wishes to address the county board during the “Citizen Comments” portion of the county board meeting must verbally state their name and residential address for the record.
- Citizens that speak during “Citizen Comments” must list their name and residential address on the sign-in sheet on the podium.
- Citizen Comments portion of the meeting will be for 1 hour, which may be adjusted by the County Board Chair at their discretion, if necessary.
- Each speaker is provided one opportunity to speak up to five (5) minutes in length or as announced by the County Board Chair at the beginning of the meeting. Stay within the time limits provided.
- Citizen comments should pertain to county operations.
- Comments should be made to the Board as a whole, and not to address individual Supervisors.
- Do not ask questions of the Board as a whole, or to individual supervisors, this is a time for public comments, not discussion or debate.
- Citizens must be courteous in their language and deportment and must avoid personalized remarks. Refraining from comments that are rude, obscene, or profane, personally attacking, or which demonstrate a lack of respect for others.
- The County Board Chair will not tolerate abusive language or disruptive behavior. The County Board Chair, for abusiveness or disruptive behavior, may terminate an individual’s public comments. The County Board Chair has the authority to rule speakers out of order for noncompliance with these guidelines and may call a short recess in disorderly situations.
- Citizens in the audience are not to audibly respond to comments being made or to make demonstrations either in support of or in opposition to a speaker or idea. Refraining from derogatory comments, inappropriate gesturing, or applause.

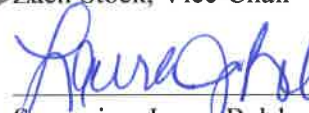

WHEREAS, the Constitution of the United States is the Supreme Law of our nation, and;

WHEREAS, the Right of the People to Keep and Bear Arms is guaranteed as an Individual Right under the Second Amendment to the United States Constitution, and reads "A well regulated Militia, being necessary to the security of a free state, the right of the people to keep and bear Arms, shall not be infringed," and;

WHEREAS, the Constitution of the State of Wisconsin, Article 1, Section 25, reads "The people have the right to keep and bear arms for security, defense, hunting, recreation or any other lawful purpose," and;

WHEREAS, the United States Supreme Court in *District of Columbia v. Heller*, 554 U.S. 570 (2008), affirmed an individual's right to possess firearms, unconnected with service in a militia, for traditionally lawful purposes, such as self-defense within the home, and;

WHEREAS, the United States Supreme Court in *McDonald v. Chicago*, 561 U.S. 742 (2010), affirmed that the right of an individual to "keep and bear arms," as protected under the Second Amendment, is incorporated by the Due Process Clause of the Fourteenth Amendment against the states, and;

WHEREAS, the United States Supreme Court in *United States v. Miller*, 307 U.S. 174 (1939), opined that firearms that are part of ordinary military equipment, or with use that could contribute to the common defense are protected by the Second Amendment, and;

WHEREAS, the Right of the People to Keep and Bear Arms for the defense of Life, Liberty, and Property is regarded as an Inalienable Right by the People of the Kenosha County, and;

WHEREAS, the People of Kenosha County derive an economic benefit from all safe forms of firearms recreation, hunting, and shooting conducted within Wisconsin using all types of firearms allowable under the United States Constitution and the Constitution of the State of Wisconsin, and;

WHEREAS, the Citizens of Kenosha County are concerned about the passage of any bill containing language which could be interpreted as infringing the rights of the citizens of Kenosha County to keep and bear arms, and;

WHEREAS, The Kenosha County Board of Supervisors desires to hear the views of the public on this important matter; and subsection 59.52 (25) of the Wisconsin Statutes permits the County Board of Supervisors to conduct a countywide referendum for advisory purposes, and;

WHEREAS, The following advisory referendum question provides a way for the public to express its views on making Wisconsin a 2<sup>nd</sup> Amendment Sanctuary State:

Question: Should the Wisconsin State Legislature declare the State of Wisconsin be a Second Amendment Sanctuary State?

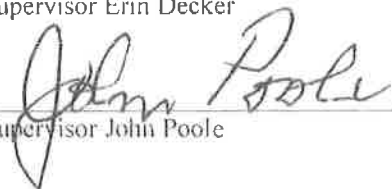

Any training or training materials that the recipient -- or any subrecipient ("subgrantee") at any tier -- develops or delivers with OJP award funds must adhere to the OJP Training Guiding Principles for Grantees and Subgrantees, available at <https://ojp.gov/funding/Implement/TrainingPrinciplesForGrantees-Subgrantees.htm>.

**Description:** Through this grant announcement, the Wisconsin Department of Justice (DOJ) is seeking applications to develop and implement a comprehensive plan establishing a law enforcement deflection program that allows non-violent offenders struggling with drug addiction to be diverted from arrest and receive assistance obtaining treatment within the community. Successful applications should establish pre-arrest or post-arrest law enforcement or other first-responder deflection programs for individuals who commit low level, non-violent, drug-related offenses to community-based substance abuse and behavioral health services.

The overall intent of this project is to expand existing programming and emerging options to address the opioid epidemic. The Wisconsin Department of Justice's Bureau of Justice Information and Analysis will act as the research partner for this project. Priority considerations include the high and quickly rising rates of opioid deaths and primary treatment admissions, and the heightened needs of the many rural, remote, and tribal regions of Wisconsin.

The goals of a deflection program are to address the underlying substance use needs of non-violent offenders and to reduce exposure to the justice system. - Led by the law enforcement agency.
- Establish processes and/or criteria to identify appropriate participants.
- Establish resources to refer the client to a treatment provider or coordinator.

**Anticipated Funding Amount:** A total of up to \$600,000 is available to support at least four sites to be selected by a peer review panel at the Wisconsin Department of Justice (DOJ). Each site will be eligible for up to \$150,000 for a planned project period that runs through July 31<sup>st</sup>, 2023.

If you receive an award under this grant announcement, there may be an opportunity to apply for additional funding to run the program through 2024. That opportunity is dependent on the availability of federal formula grant funds and satisfactory program performance.

**Match/Cost Sharing Requirement:** There is no match required under this program.

**Eligibility:** Funding will be awarded to at least four local sites to develop law enforcement deflection programs. Site selection will vary based on existing capacity, existing structures, and underserved or rural geographic areas of the state. In determining these selections, factors will include support of the local criminal justice coordinating council (CJCC), treatment resources, other Treatment Alternatives and Diversion or drug court programming within the county, proposed program capacity, existing alternative to incarceration programs and data regarding Wisconsin State Crime Lab case submissions and/or overdose fatality data.

**Eligible Expenses:**

Funding may be used for Personnel, Employee Benefits, Travel/Training, Equipment, Supplies & Operating Expenses, Consultants/Contractual, Other.

Funds are intended to be spent funding a deflection program which could include hiring new staff, establishing treatment services, implementing a peer support network, or supporting recovery or transitional housing.

**Requirements for Federally Funded Grants:**

**System for Award Management (SAM) Registration:**

## **Comprehensive Opioid, Stimulate and Substance Abuse Site-Based Program (COSSAP): Law Enforcement Deflection Program 2019 (2022)**

The Wisconsin Department of Justice (DOJ) through its Bureau of Justice Programs (BJP) provides financial and technical assistance to public safety and criminal justice agencies throughout the state. As the state administering agency (SAA) for state and federal juvenile and criminal justice programs DOJ is responsible for establishing funding priorities, developing application criteria, awarding and disseminating grants, and assessing project achievements. This grant announcement provides information about a specific grant opportunity and instructions to help those eligible apply for a share of the available funds.

### **Program Description and Background**

Signed into law on July 22, 2016, the Comprehensive Addiction and Recovery Act (CARA) is the first major federal substance abuse treatment and recovery legislation in 40 years and the most comprehensive legislative effort to address the opioid epidemic. CARA establishes a comprehensive, coordinated, and balanced strategy through enhanced grant programs that encompass prevention and education efforts, effective responses to those affected by substance abuse, and services for treatment and recovery from addiction. The Comprehensive Opioid, Stimulate and Substance Abuse Site-Based Program (COSSAP) was developed as part of the CARA legislation. COSSAP's purpose is to provide financial and technical assistance to states, units of local government, and Indian tribal governments to plan, develop, and implement comprehensive efforts to identify, respond to, treat, and support those impacted by the opioid epidemic.

The FY19 COSSAP is an initiative to support the implementation of local site-based programming throughout the State of Wisconsin. Specifically, this statewide effort seeks to build on emerging efforts to address gaps in addressing opioid abuse in Wisconsin, through the development and implementation of a comprehensive plan that establishes a law enforcement-assisted deflection program, allowing non-violent offenders struggling with drug addiction to be diverted from arrest and receive assistance obtaining treatment within the community. Successful applications should establish pre-arrest or post-arrest law enforcement or other first-responder deflection programs for individuals who commit low level, non-violent, drug-related offenses to community-based substance abuse and behavioral health services.

Funds will be used to support at least four local implementation sites under this program, as well as to build needed infrastructure at the state level to support the implementation of these program models. Through this grant announcement, DOJ is seeking applications from local jurisdictions in Wisconsin to develop law enforcement deflection programs specifically designed to address opioid abuse. In collaboration with the Wisconsin Department of Health Services, the Wisconsin Department of Justice, as the State Administering Agency, will administer the subaward process, selection of sites, assist with training the sites, collect performance data from the sites, provide ongoing technical assistance to the sites, and provide overall grant monitoring and oversight. This strategy is based on a number of factors, including the State Criminal Justice Coordinating Council's role as an advisory body, and participation in the National Institute of Corrections' Evidence-Based Decision-Making Initiative, the recent expansions of the Treatment Alternatives and Diversion program, and recently enacted state legislation to provide initial funding for the proposed program models.

**Target Population**

Evidence-based practices indicate that individuals with whom law enforcement officers interact have different levels of risk and need and should be served accordingly. In defining their population, applicants should adhere to evidence-based practices, using validated tools to assess the risk and needs of their population and determining which individuals are appropriate to receive services based on research to reduce incarceration and interaction with the criminal justice system.

**In addition to the general items above, Law Enforcement-Assisted Deflection programs should address the following:**

**Research and Evaluation**

In applying for these grants, applicants agree to cooperate in any and all related research efforts and program evaluations by collecting and providing enrollment and participation data during all years of the project. Applicants also agree to provide detailed individual-level data, in the format specified by DOJ during this time period (and for a follow-up period for recidivism data).

Applicants are encouraged to consider a partnership with a local research organization that can assist with data collection, performance measurement, and local evaluations.

Note: All successful applicants will be expected to secure permission from all program participants to collect and report on administrative data pertaining to criminal status.

All applications must be submitted on or before 11:59 pm on the deadline and will be screened for completeness and compliance with the instructions provided in this announcement. All compliant applications will be reviewed on a 36-point scale, based on the following point values for the selection criteria:

- Budget Narrative (Up to 3 points)
- Problem Description (Up to 12 points)
- Project Design (Up to 9 points)
- Implementation Plan (Up to 6 points)
- Goals and Objectives (Up to 3 points)
- Letters of Support (Up to 3 points)

Although the point values will be assigned as shown above, applications will only be considered if all of the indicated sections (#1 - #10) are submitted.

Top scoring applications will include detailed responses that demonstrate a well-thought-out program that is supported by critical partners. Answers in each section should fully answer the question, including specific answers to each sub-question, and align logically with answers to other sections so that when read together, the application will provide a comprehensive overview of the proposed program.

The review ratings and any resulting rankings or recommendations are advisory. In addition to review ratings, consideration may be given to factors such as: underserved populations, strategic priorities, past performance, underserved geographic areas, and available funding. Once ranked, the applications will be submitted to the Attorney General for further review and comment. Depending on resources, grants will be funded in the final ranked order until grant funds are exhausted. Each grant must satisfy the basic criteria set out above. Grant applicants will be contacted if more information is needed to clarify elements of their proposal, and grant reviewers may suggest amendments to applications. All final grant award decisions will be made by the Attorney General.

### **Award Information**

Upon application approval, the applicant agency's project director will receive signed grant award documents within approximately 30 days via email. This includes timely completion of progress and financial reports, active efforts to achieve and measure stated goals and objectives, appropriate documentation of activities and outcomes, on-going submission of participant data, and adherence to any conditions included in the grant award.
2. All awards are subject to the availability of appropriated funds and to any modifications or additional requirements that may be imposed by law.
3. The DOJ reserves the right to withhold grant payments if the grant recipient is delinquent paying any obligation to DOJ such as background check fees, etc. Refusal to provide information requested by DOJ may impact the payment of current or approval of future grant funds.
