Supervisor Poole made a motion to accept the budget by the Judiciary & Law committee to move the purchase of Tazers from the bonding budget to operating budget. Supervisor Wamboldt second the motion for the sake of discussion. Motion failed on the following roll call vote to remove the Tazers from the bonding budget and into the operational budget.
