WHEREAS, Kenosha County Public Health will be receiving \$1,233,500 in American Rescue and Recovery Act (ARPA) funding over 3 years to assist with the response and recovery from the COVID-19 Pandemic. This will include looking at services that were delayed due to the pandemic, investments in infrastructure, and focusing on health disparities; and

WHEREAS, Kenosha County Public Health will be receiving \$238,400 over 3 years to support increased equity and access to the COVID-19 vaccine to communities disproportionally affected by the virus. This funding will also support logistics, staffing, communications, outreach, site-specific needs and supplies for community vaccination efforts for underserved populations; and

**WHEREAS**, Kenosha County Public Health will be receiving \$212,700 over 2 years to conduct activities to expand, train, and sustain and response-ready public health workforce. This will assist with hiring COVID disease investigation staff and maintain the existing public health staff assisting with the COVID response;

**NOW, THEREFORE, BE IT RESOLVED** based on the aforementioned, that the Kenosha County Board of Supervisors hereby approve Kenosha County Public Health's acceptance and spending of American Rescue and Recovery Act, Immunization, and Public Health Emergency Preparedness Workforce grants.
