Description of Accident or Loss:

I was travelling southbound in the left lane of I-94. Shortly before exit 342 for Highway 158, I hit a pothole in the middle of the lane and heard two loud pops. I was able to change lanes and pull over to the right shoulder of the highway. Upon inspection of my vehicle, I found that both front and rear tires and (at the time I thought just the front) wheel rim on the passenger side were shattered. The Kenosha County Sheriff's Office responded, and officer Kless (unit #299) informed me that there had been several other incidents with this same pothole and damage to other vehicles. Jensen Towing transported my vehicle to Kenosha tire. I opted to replace all four tires, which is shown on the receipt, but the total figure on the claim form includes half of the cost of the tires for the two that were damaged beyond repair. I had trouble locating a wheel rim for my vehicle but was eventually able to purchase one from Griffin Ford in Waukesha where my parents picked it up and drove it to me in Kenosha. After Kenosha Tire looked at my vehicle, they found that the rear wheel rim on the passenger side was also massively damaged and cracked and that the tire sensor also had to be replaced. They installed three new tires and one new wheel rim and put my spare tire on my vehicle, and I drove back to Waukesha where I purchased a second rim and tire sensor from Griffin Ford. They installed the fourth tire on the new wheel rim but were closing for the day, so I had to replace the spare with the new tire and rim that evening.


