Minutes of the Kenosha County Planning, Development & Extension Education Committee public hearing held on Wednesday, March 11, 2020 at 6:00 p.m. in the Kenosha County Center Public Hearing Room, 19600 -75th Street, Bristol, Wisconsin.

The meeting was called to order at 6:00 p.m. by Chairman Decker.

- 1. **Certification of Compliance with Wisconsin Open Meetings Law:** The committee certified that all requirements of the Wisconsin Open Meetings Law had been met
- 2. Feature Program "Real Colors Personality Assessment and Team-Building in Organizations": Amy Greil, Community Development Educator, presented an overview of the Real Colors program and shared examples of how she works with groups on team building skills. The Supervisors learned about four personality styles, created from long-standing research used by the National Curriculum & Training Institute who created the "Real Colors" program. Amy Greil, Bethany Sorce, Vickie LeFlore and Bev Baker are certified trainers, and provide the workshop as part of the Leadership Kenosha program, along with Economic Support staff and other groups. Each color represents a personality trait, and the workshop promotes communication through understanding how the other color groups work most effectivity, which is very beneficial to businesses and organizations.

3. UW-Extension Educator/Program updates:

Mary Metten, Health & Well-Being Educator, noted her Mental Health First Aid workshop reached 24 adults and 22 youth participants. She is working on the Child Abuse and Neglect Awareness month programs, which includes Darkness to Light on April 21 focused on child sexual abuse prevention. Nominations will be open soon for the Strong Family Awards.

Amy Greil, Community Development Educator, reported that the Kenosha County Food Bank has launched and she will serve in a volunteer role as interim president of the board

of directors. She is planning a large community event in Uptown/Brass Neighborhood that will provide in depth information from two studies regarding gun violence and housing issues and absenteeism, pending COVID-19 restrictions. MRA, a large human resources firm, and Amy are collaborating on a conference focused on resources to support hiring of formerly incarcerated re-entrants for the Workforce Development Project.

4. **UW-Extension Director's Report:** Bev Baker, Area Extension Director, reported that the office move to be co-located with Planning and Development is close to completion. Christine Wasielewski, with the Sustainable Kenosha County team, is creating the Kenosha County Swap so unneeded items can be posted to a Sharepoint site and other departments can acquire the unused items instead of having to purchase new.

Last year, Vijai Pandian, Horticulture Educator, was hired to work in Kenosha, Milwaukee and Racine counties. After Horticulture Program Coordinator Caitlin Sprague resignation, Vijai will now work primarily in Kenosha and Racine counties, including oversight of the Master Gardener Program. Milwaukee County will hire their own Horticulture Educator. One of Vijai s large projects is reorganizing the Horticulture Helpline/Plant Health Advising offices staffed by Master Gardener Volunteers so they now have one email and phone number consistent at each of the three sites (Kenosha County Center, Racine County Ives Grove Offices, and Boerner Botanical Garden.) As a result, there are greater efficiencies, higher quality research-based responses, and more coverage (instead two mornings, questions can be answered 6 days/week during the growing season.)

UW-Madison Extension set a recent policy that any Extension programs with 50 or more participants are to be cancelled through April 10 due to the COVID-19 pandemic. Staff have access to Zoom Pro accounts to transition programs if a viable solution. Staff is being very creative how to deliver their programs.

Chairman Decker called for a brief recess prior to reconvening for the Public Hearing portion of this meeting.

After a brief recess, the Public Hearing was called to order at 7:00 p.m. in the Public Hearing Room (Recording #2 of 2).

Chairman Decker called for introductions of committee members, youth in governance, and staff.

Division Director Buehler noted that agenda items 6, 7, 8, and 10 were tabled by the Town to allow additional time to act on the applications.
