The meeting was called to order at 6:05 p.m. by Robert Stoll. Let it be known this meeting was held telephonically due to the COVID-19 shutdown. While Board members and support staff met in person, the applicants called in via telephone to participate in the meeting.

- 1. THOMAS L. CARLSON JR., 7829 336th Ave., Burlington, WI 53105 (Owner), requesting a variance (Section IV. C. 12.21-4(g)1: which states that all structures shall be located not less than 30 feet from the right-of-way of all other roads) to allow the existence of an already constructed covered porch addition having a street yard setback of 16 feet from 336th Ave on Tax Key Parcel #95-4-119-111-3285, Town of Wheatland.

S. 12.18.7-4: which states that It shall be unlawful to proceed with the operation, construction, installation, enlargement or alteration of a temporary use, as defined in this ordinance, without first obtaining approval from the Kenosha County Board of Adjustments) to temporarily use an existing field for the placement of a 30' x 90' sales tent, a 8' x 40' metal storage container and multiple signs to **operate a temporary fireworks sales stand** in the B-3 Highway Business Dist. on Tax Parcel # 95-4-219-323-0305, Town of Wheatland.
- 3. Mr. Devito made a motion to approve the temporary use permit request of Action 50 LLC to temporarily use an existing field for the placement of a 30' x 90' sales tent, a 8' x 40' metal storage container and multiple signs to **operate a temporary fireworks sales stand** in the B-3 Highway Business Dist. on Tax Parcel # 95-4-219-323-0305, Town of Wheatland.
