Minutes of the Kenosha County Planning, Development & Extension Education Committee public hearing held on Wednesday, August 11, 2021, at 6:00 p.m. at the Kenosha County Job Center, 8600 Sheridan Road, Kenosha, Wisconsin.

The meeting was called to order at 6:00 p.m. by Chairman Gaschke.

1. **Certification of Compliance with Wisconsin Open Meetings Law:** The committee certified that all requirements of the Wisconsin Open Meetings Law had been met.

Chairman Gaschke informed the committee that the vacancy created by Bev Baker's retirement has been filled. He introduced Terri Ward, noting she has been hired as the Kenosha/Racine Area Extension Director. He invited the committee to join him in congratulating and welcoming Terri to Kenosha County. Amy Greil, Community Development Educator, noted that she was part of the interview team for the position and that Terri is highly qualified for the position based on her experience as FoodWise Administrator, noting that the team Terri has been guiding is among the most efficient and highest performing nutrition education office in the State. Terri will officially begin her capacity as Area Extension Director August 15th.

2. **Feature Program: "Summer parks programming - Working with existing partners to support healthier choices by youth"** – Nicole Leipski, Teaching Coordinator, presented. Specifics are detailed in the presentation attachment. Nutrition education was recently provided in Kenosha at Lincoln Park, which included games and projects to make learning fun.
3. **Youth In Governance:** There were no updates at this time.

4. **UW-Extension Educator/Program updates:**

Amy Greil, Community Development Educator, provided a copy of an article she is working on and requested comments and guidance. The article is regarding unemployment and Kenosha County. The Committee requested the information be more specific such as how many are currently receiving benefits and the most current unemployment rate. They mentioned concerns that the higher rate of unemployment being paid due to the pandemic may discourage the unemployed from going back to work because they can make more from unemployment payments than going back to lower rate of pay jobs. They also noted businesses are experiencing difficulties attracting a qualified, reliable workforce, even at offering competitive wages.

Terri Ward, FoodWise Program Administrator, provided an update for Jen Reese, Interim 4-H Coordinator, noting that three camps had just been held: Base Camp, Adventure Camp and Day Camp; the Kenosha County Fair is coming up August 18 – 22; 4-H will have the pizza and pop stand to support 4-H programs; volunteer orientation will be held September 18th; and enrollment begins October 1st for youth in grades 5K – 12, plus one year after graduation.

5. **UW-Extension Director's Report:** Terri provided an update for the FoodWise office noting nutrition education will take place through summer in the parks; a strength training program was held virtually for seniors at Assisi Homes of Kenosha; the administrator position has been posted to fill her vacancy; and she has been busy working on the FY2022 FoodWise agreements that must be submitted for all community partners

Chairman Gaschke informed the Committee that as has been past practice, the 2022 Budget hearings for the Planning & Development and UW Extension offices will be held during the 6:00 p.m. session of the October 13 meeting; land use hearings will be held immediately after at the regular 7:00 p.m. timeframe.

Chairman Gaschke called for a brief recess prior to reconvening for the Public Hearing portion of this meeting.

After a brief recess, the Public Hearing was called to order at 7:00 p.m. in the Public Hearing Room (Recording #2 of 2).

Chairman Gaschke called for introductions of committee members, youth in governance, and staff.

6. **Review and Possible Approval** – Resolution requesting approval of the formation of a Silver Lake Management District within Kenosha County pursuant to Wis. Stat. § 33.25. (1:30)

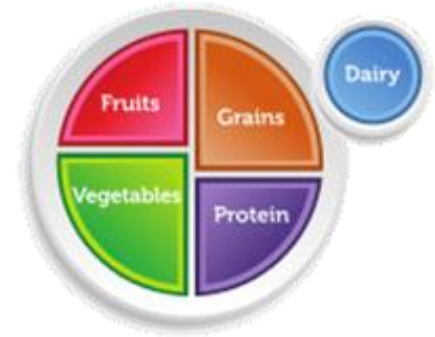

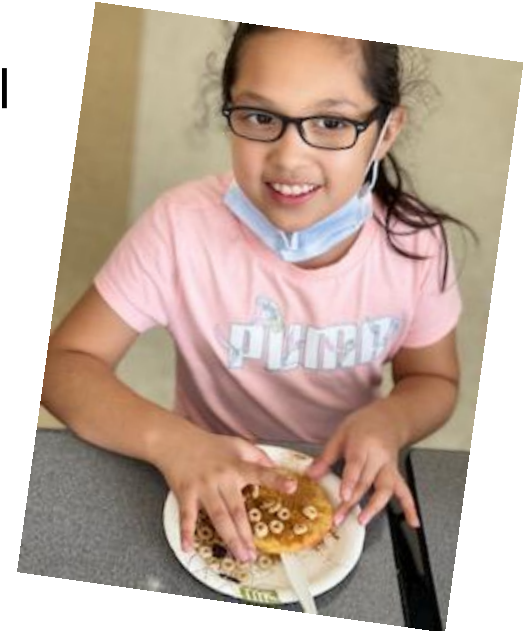
