The **Regular Meeting** was called to order by Chairman Molinaro at 7:30 p.m., in the County Board Room located in the Administration Building.

Roll call was taken.

CITIZEN COMMENTS

Mark Montague, 7835 36th Ave., stated he is sure the number of the deficit has been satisfied and wondered how much more time will be wasted before the laid off highway department employees are called back to work. It's going to be November and it's going to be snowing soon. Every supervisor will have their phone ringing because of the things that have not been getting done. They've been doing their best with half a crew, punching in with less than 30 people. He would like to know if and when the 14 will be coming back.

Bob Danbeck, 7626 27th Ave., stated Chrysler, the largest tax payer in the county is closing this week and one of the committees decided to give the supervisors a 50% pay raise. He feels a way to save money is to get rid of the line item out of the budget for health insurance for supervisors. He believes a line item can be cut out of the budget without any repercussions at all. The board needs to be responsible to the tax payers. He is going on his second year without a raise in social security, but yet his taxes are going to be raised. He is going to get the City Council to downsize the amount of alderman which will require the county board, by state statute, to downsize the city portion of the county board. He would also like to see the county board meetings televised live.

At this time Captain Paul Falduto from the Sheriff's Department and Shawn Smith, Information Technologies Customer Service Manager gave a presentation of the Broad Band Wireless Initiative as outlined in the 2011 County Budget.

ANNOUNCEMENTS OF THE CHAIRMAN

Chairman Molinaro announced that the Hope Council's Halloween Party will be October $22^{\rm nd}$ at the Kemper Center. He urged the committees to be diligent in making sure the minutes are posted on the website in a timely manner. There was an article in the paper about a drug that is being used in place of marijuana which is called K2. He asked Supervisor Kubicki and the Legislative Committee to look into this issue and make a determination if the County Board should take a position on this product in Kenosha County. It is a clear intent to provide a product for a use that it should not be used for.

Chairman Molinaro reminded the board of the commitment to stay within the 2.75 recommendation the board came to in June regarding the budget. The leadership of the board is committed to it and has had extensive discussions about it. He stresses to the committees that the hard work is in committee, and he has no pressure to put this on the agenda on November 9^{th} if we're not prepared to do it.

SUPERVISOR REPORTS

Supervisor Elverman stated last Saturday they had their first open house out at the property developing at Hwy KD & F. It was very well attended. There will be another one on October $30^{\rm th}.$

Supervisor Kubicki stated the Legislative Committee met earlier and unanimously passed the Corporation Counsel's budget.

Supervisor Noble reported the Administration Committee met and approved the Local 1392 contract. They also went through the Personnel Budget and reclassification requests; some were passed and some denied. They went through the miscellaneous budgets including the workman's comp. and insurance and made a \$90,000 cut in insurance by removing the flex spending from the non-rep employees. These have all been passed on to Finance Committee. The County Board compensation was passed 4-0 by the committee. It was a substituted resolution by Supervisor Gail Gentz which may save \$100,000. The resolution eliminates insurance for supervisors and gives a pay increase of \$3000. Supervisor Ron Frederick noted that the supervisors pay has only increased \$400 in the past 20 years. They will bring this forward after the budget is passed since this can't take effect until 2012.
