### JUNE 5, 2007

The **Regular Meeting** was called to order by Chairman Rose at 7:30 p.m., in the County Board Room located in the Administration Building. Roll call was taken.

Presentation and discussion by Wisconsin Department of Transportation (WISDOT) staff regarding I-94 reconstruction in Kenosha County.

SUPERVISOR REPORTS

Supervisor Marrelli gave a report from Extension Education regarding the Quad Counties Report. Extension Education is involved in the Smart Growth Planning Process. Kenosha has a Junior Master Gardner Program and involves  $3^{\rm rd}$  to  $6^{\rm th}$  graders. It is free. On Friday, August  $3^{\rm rd}$  a fair will be held in the city from 4:00 to 8:00 p.m.

Supervisor Noble reported on Highway & Parks Committee. Regarding the impact for Kenosha County residents with the Illinois Toll. A 8 1/2 mile section of highway, the south-bound lanes are scheduled for reconstruction in 2007. This is noted for huge pot-holes. Also, the second phase of paving from County Highway N to County Highway 31 is currently being advertised for bids. This includes traffic signals at Highway S & H. Starting June  $11^{\rm th}$ , the first project for county highway improvements will begin with County EA which is from W to County E. This project is carried over from 2006 due to weather. State Highway 50 bridge is scheduled for between June  $15^{\rm th}$  and August  $15^{\rm th}$ .

Supervisor Huff stated that the Legislative Committee held hearings regarding the size of the County Board and the committee be taking up this issue and bringing it before the County Board.

Supervisor Michel thanked the Sheriff for his department's acknowledgement and services for Deputy Fabiano who was killed in the line of duty.

Chairman Rose asked everyone to stand for a moment of silence in recognition of Deputy Fabiano.

An Ordinance to Amend Section 10.07 (2) of the Municipal Code Regarding Prohibited Actions in County Parks.

The Kenosha County Board of Supervisors does hereby ordain that section 10.07 (2) of the Municipal Code of Kenosha County be, and hereby is, amended to read as follows:

(2) It shall be unlawful for any person to remove, destroy, break, injure, mutilate, or deface in any structure, monument, statue, vase, fountain, wall, fence, railing, vehicle, bench, tree, shrub, fern, plant, flower or other property in any park, except for gathering mushrooms for personal use only in any park areas not specifically designated as a nature center. WHEREAS, the Sheriff Department has brought in approximately \$14.7 million dollars in revenue to the county from the housing of said inmates, and

WHEREAS, the 2007 County Budget included an appropriation of \$2,970,000 for the conversion of the industrial center at the Kenosha County Detention Center )KCDC) facility into a 118 hard cell housing units, and

WHEREAS, the Kenosha County Detention Center Renovation bids have resulted in an actual cost estimate of \$3,470,000, and

WHEREAS, the project was to be partially funded with \$5000,000 of revenue from the sale of County owned land, and

NOW, THEREFORE, BE  $\overline{\text{IT}}$  RESOLVED, that an additional \$500,000 be appropriated for the construction of cells at the KCDC, and

BE IT FURTHER RESOLVED, that if the sale of land does not occur the shortfall of funding for the project be funded with surplus jail revenue from the housing of inmates or bonding, or a combination of both, and that the amounts be determined prior to the issuance of the 2007 debt as described in the attached fiscal note, and

BE IT FURTHER RESOLVED that Kenosha County Board of Supervisors modify the County Budget as per the attached budget modification form which is incorporated into this resolution by reference.

### RESOLUTION 26

26. From Legislative and Judiciary & Law Committees Urging Congress to Amend Federal Law to Allow Federal Financial Participation in Providing Medical Benefits to Incarcerated Individuals Until Convicted and Sentenced to Secure Detention.

WHEREAS, U.S. Code of Federal Regulations, Title 42, Part 435.1009 states that Federal Financial Participation (FFP) is not available in expenditures for services provided to individuals who are inmates of public institutions; and

WHEREAS, states being unable to assume the federal share of providing medical services to FFP eligible persons being held in county jails and detention facilities, tend to terminate or sometimes suspend eligibility; and

WHEREAS, this immediate cessation of benefits occurs prior to the issuance of formal charges or conviction; and

WHEREAS, counties must provide medical services to all persons incarcerated in local jails and detention facilities; and

WHEREAS, as a result of this regulation to immediately cease FFP for medical benefits, all costs of medical care must be borne solely by counties.

 ${\bf NOW,\ THEREFORE,\ BE\ IT\ RESOLVED}$  by the Kenosha County Board of Supervisors that this Board:

- 1. Urges the U.S. Congress and the U.S. Department of Health and Human Services to amend federal law to allow federal financial participation in providing medical benefits to incarcerated individuals until convicted and sentenced to secure detention.
- 2. Directs the Clerk of the Board to transmit a certified copy of this resolution to the members of our Congressional Delegation and the Secretary of the U.S. Department of Health and Human Services
- 3. Directs the County's federal lobbyists to advocate for the passage of the legislation and/or rule change set forth in paragraph 1. above, and directs the Office of Intergovernmental Affairs to include this item in the 2007 Federal Legislative Package.
