CITIZEN COMMENTS

Lou Rugani, 4526-29th Avenue, Kenosha, spoke regarding a Permanent Homeless Shelter has taken another step forward. He has been a landlord since 1979. What makes a homeless person? Failure to pay rent, unimaginable damage to property, illegal activity, domestic abuse, moving other people in without authorization, waste, disturbing the neighbors, complaints from the police etc. The County Board has a quarter of a million dollars allocated for a homeless shelter. The worst thing you can do is have a permanent shelter. A lot of the people in favor of the shelter are from the county. Not in their back-yard. We can't afford "Come to Kenosha and see what you can get for free!" This will destroy Kenosha.

CHAIRMAN'S COMMENTS

SUPERVISOR REPORTS

Supervisor Singer spoke regarding the Communication pertaining to the Memorandum of Understanding for Construction of a Temporary Parking Lot. Fred Patrie explained that the Construction of a Temporary parking lot located north of $54^{\rm th}$ Street and east of Sheridan Road was approved by Kenosha Redevelopment Authority. The work will start on May $22^{\rm nd}$.

Supervisor Moore stated that he was able to attend the U. W. Extension Training for new supervisors and he found it to be extremely helpful. A couple weeks ago himself and Supervisor Jackson were able to attend the WCA District Meeting in West Bend. That the map referred to in Section 12.02(a) of the Kenosha County General Zoning and Shoreland/Floodplain Zoning Ordinance be amended as follows: That Tax Parcel #80-4-222-0274-0403 located in the southeast quarter of Section 27, Township 2 North, Range 22 East, Town of Somers have a PUD Planned Unit Development Overlay District amended and applied as presented. The petitioner requests development of a 2 story 22,400 square foot proposed retail/office building on a portion of the above described parcel currently zoned B-2 Community Business District. For informational purposes only, this property is a part of the Avalon Parc Condominium project located on the west side of State Trunk Highway 31 (Green Bay Road) at the intersection of $43^{\rm rd}$ Street.

The petitioner's original application (approved in April 2004) stated that when the developer was ready to develop the B-2 Community Business District portion of the project, he would apply for an amendment to the PUD with a detailed site plan and elevation of the commercial building.

The petitioners would be responsible for compliance with their testimony given at the May 10, 2006 Land Use Committee public hearing, whereby assurances were given, exhibits were presented, information explained and received, all which are now part of the record, along with complying with the application and various site plans previously filed with the County.

In addition, the petitioner is responsible for compliance with conditions as requested by the Department of Planning and Development, which were agreed to by the petitioner at the May 10, 2006 public hearing. These conditions are hereby referenced to as (Exhibit 1), on file in the Department of Planning and Development and are made part of this ordinance.

The petitioner also is responsible for compliance with the PUD Planned Unit Development Overlay District conditions as outlined in Section 12.26-4(a-o) of the Kenosha County General Zoning and Shoreland/Floodplain Zoning Ordinance.

A public hearing was held on May 10, 2006 by the Land Use Committee for the purpose of receiving evidence, taking testimony, and reviewing recommendations presented. At that time, a favorable recommendation was given to the zoning request for the application of a PUD Planned Unit Development Overlay District for the WAB, LLC commercial development project by the Land Use Committee on the property as previously described.

2. From Finance Committee Establishing an account to allow for Direct Debiting of Health Insurance Payments.

RESOLUTION 3

3. From Finance Committee $\overline{\text{Resolution}}$ to purchase Accessible Voting Equipment.

WHEREAS, in order to comply with the requirements of the Help America Vote Act of 2002 (HAVA), the State Elections Board has allocated Eighteen Million Dollars (\$18,000,000) in Federal HAVA funds for the purchase of one accessible voting system as required by HAVA for each polling location in the State of Wisconsin, and

WHEREAS, the Elections Board is offering reimbursement of up to Six Thousand Dollars (\$6,000) **per unit** for the purchase of one accessible voting system per polling place in Kenosha County, and

WHEREAS, it would be more efficient for Kenosha County, through it's County Clerk to provide a coordinating role in the acquisition process of the systems for the 52 polling places in Kenosha County on behalf of the Municipality that must otherwise obtain the systems for their polling places at a possible higher cost, and

WHEREAS, Kenosha County will submit an Accessible Voting Equipment Funding Application on behalf of Municipality to the State Elections Board, and

WHEREAS, the County will purchase the TSX (Touch Screen Voting Devise) produced by Diebold Election Systems which is completely compatible with the equipment currently used by municipalities in Kenosha County and will negotiate the best price possible, and

WHEREAS, the local unit of government agrees that any funds remaining from the \$6,000 allocation will be used to cover any coding costs and/or maintenance agreements necessary, plus the purchase of a TSX to be used by the county for coding, testing and training purpose, and

WHEREAS, County Tax Levy is unaffected by this Resolution.

NOW THEREFORE BE IT RESOLVED that Kenosha County will make payment to the vendor for the total sum necessary to purchase the handicap accessible voting equipment but not more than Six Thousand Dollars (\$6,000), per unit the maximum amount of the reimbursement funding and that the County Clerk's budget be modified as per the attached Budget Modification form and incorporated by reference.

WHEREAS, The Kenosha County Division of Aging Services has received a Community Links Workforce and Community Capacity Building Project grant for 2006 from the Wisconsin Division of Disability and Elder Services, and

WHEREAS, The State of Wisconsin has embarked on their ICF/MR Restructuring Initiative, requiring Kenosha County to develop plans for 52 residents in institutional settings, with 38 potential community placements, and

WHEREAS, these funds will be used by the Division of Disability Services to provide start-up funding for a care manager to assist with relocations from Intermediate Care Facilities for persons with developmental disabilities, and

WHEREAS, County Levy remains unaffected by this resolution,

NOW, THEREFORE, BE IT RESOLVED that the 2006 budget of the Division of Aging Services be modified as follows:

Expenditures and Revenues increase by \$64,084 as indicated in the attached budget modification form, which is incorporated into this resolution by reference.

WHEREAS, the application of Patricia Briese for a probationary cabaret license for Briese's Bar & Grill, $1170-22^{\rm nd}$ Avenue, Kenosha, Wisconsin, in the Town of Somers, wads made during the month of September, 2005, was turned over to this office on September 29, 2005, and

WHEREAS, the establishment known as Briese's Bar & Grill was granted a Probationary Cabaret License per County Board Resolution on November $15^{\rm th}$, 2005, and

WHEREAS, the establishment known as Briese's Bar & Grill was found to be in conformity with County Ordinance #8.02 governing it's conduct for a probationary period of the last 6 months.

NOW, THEREFORE, BE IT RESOLVED, that a regular cabaret license, in lieu of a probationary cabaret license, be granted to Patricia Briese, for Briese's Bar & Grill.

RESOLUTION 7

7. From Judiciary & Law Enforcement and Finance Committees regarding Wisconsin Act 59 which allows the counties to charge and collect a reasonable amount to assist in the efficient collection of amounts ordered to be paid to the Clerk of Circuit Court for the use of credit and debit cards of three percent of the transaction amount and an amount not to exceed \$15.00 for establishing and monitoring a payment plan.

WHEREAS, 2005 Wisconsin Act 59, which includes various provisions pertaining to the collection of fees, fines, forfeitures and surcharges owed to counties and municipalities, will become effective April 2, 2006, and

WHEREAS, included in 2005 Wisconsin Act 59 are the following provisions which apply to required payments to the clerk of circuit court.

- The clerk of circuit court may accept a credit card or debit card for any required payment to the clerk of circuit court.
- The clerk of circuit court may charge and collect a reasonable service fee for the use of a credit card or debit card, the amount of which fee shall be established by the county board.
- The clerk of circuit court may charge and collect a fee for the establishment and monitoring of a payment plans for persons ordered to make payments to the clerk of circuit court.
- The amount of the fee for establishing and monitoring such a payment plan may not exceed \$15 and shall be on a sliding scale based upon ability to pay as measured by income.

And,

WHEREAS, the use of credit and debit cards, subject to an appropriate charge for such service, and the establishment and monitoring of payment plans, subject to an appropriate charge for such service, would be valuable to the clerk of circuit court as an additional means to assist him/her in the efficient collection of amounts ordered to be paid to the clerk of circuit court, and

WHEREAS, for that reason, the taxpayers of Kenosha County will benefit if the clerk of circuit court is authorized to accept credit and debit cards, subject to an appropriate charge for such service, and to establish and monitor payment plans, subject to an appropriate charge for such service;

NOW THEREFORE,

BE IT RESOLVED, that the clerk of circuit court is authorized to accept a credit card or debit card for any required payment to the clerk of circuit court.

BE IT FURTHER RESOLVED, that the clerk of circuit court is authorized and directed to charge and collect the following fees for the use of a credit card or debit card:

3% of transaction amount

BE IT FURTHER RESOLVED, that the clerk of circuit court is authorized and directed to charge and collect a reasonable fee, which shall not exceed \$15 and which shall be on a sliding scale based upon ability to pay as measured by income, to establish and monitor payment plans for persons ordered to make payments to the clerk of circuit court.

BE IF FURTHER RESOLVED, that the revenue for this will be used to offset the personnel costs of the imaging project that will help to alleviate the storage space problem existing in Circuit Court.

RESOLUTION 8

8. From Land Use and Finance Committees regarding Modifying the 2006 Adopted Budget by Accepting a 2006 Planning Grant From the State of Wisconsin for a Multi-Jurisdictional Comprehensive Plan (Smart Growth Plan) to be Prepared by SEWRPC.

WHEREAS, Section 66.1001 of the Wisconsin Statutes sets forth requirements for the preparation of county and local comprehensive plans; and

WHEREAS, the comprehensive planning law effectively requires that comprehensive plans be completed and adopted by counties, cities, towns, and villages by January 1, 2010, in order for a county or local government to engage in zoning, subdivision control, or official mapping regulations and activities; and

WHEREAS, a cooperative approach among Kenosha County, local governments interested in partnering with the County, and the Southeastern Wisconsin Regional Planning Commission (SEWRPC) will result in the preparation of County and local comprehensive plans that meet State requirements and local, County, and regional needs in an efficient and cost-effective manner; and

WHEREAS, a proposed cooperative planning process was described during a series of meetings held between Kenosha County and interested cities, towns, and villages, whereby the County would contract with SEWRPC to develop a multi-jurisdictional comprehensive plan for Kenosha County and comprehensive plans for participating cities, towns, and villages; and

WHEREAS, Kenosha County applied for and received a \$364,000 2006 comprehensive planning grant from the Wisconsin Department of Administration under Chapter Adm 48 of the Wisconsin Administrative Code to help fund preparation of a multi-jurisdictional comprehensive plan for Kenosha County and comprehensive plans for participating local governments; and

WHEREAS, the grant award will be paid to SEWRPC to prepare comprehensive plans for the County and participating cities, towns, and villages, with required matching funds to be provided by the County through in-kind services and through the County's tax levy funds to SEWRPC.

NOW, THEREFORE, BE IT RESOLVED that the Kenosha County Board of Supervisors hereby agrees to sponsor and participate in the development of a Multi-jurisdictional Comprehensive Plan for Kenosha County in cooperation with participating local governments and SEWRPC, now that the County has been awarded a comprehensive planning grant by the State of Wisconsin; and

BE IT FURTHER RESOLVED that the Kenosha County Board of Supervisors hereby authorizes the County Executive to execute all cooperative agreements with participating local units of government, and to sign the grant application on behalf of the County.

BE IT FURTHER RESOLVED that a Comprehensive Planning Grant Business Unit be created per the attached budget modification form.
