#### **OWNER'S SIGNATURES NEEDED**

If you have picked up any new land, or if you have any new owners, the FSA office must have a signature of the new owner acknowledging that you will be running the farm. A requirement for this year is that we MUST have this signature by September 30<sup>th</sup>, 2010. If you do not bring in the owner's signature by September 30<sup>th</sup>, you will not receive a program payment for the 2010 crop year.

### YOU WILL NOT GET PAID FOR YOUR CONTRACTS!

If you have not signed them by <u>JUNE 1<sup>st</sup>, 2010</u> Appointment postcards were sent out in March and April to come in and sign up for the 2010 DCP/ACRE program.

Please contact the FSA office if you did not receive a postcard or have not signed up for the program yet.

#### FINANICIAL INFO AVAILABLE ONLINE

It is tax time... did you call the office to get a summary of all payments made? We are happy to assist by printing this report, but did you know you can get this information from the comfort of your own home? If you would like to be able to access your Farm Service Agency and Natural Resources Conservation Service program information from home. go www.customerstatement.usda.gov From this webpage you must first register for a Level 2 e-Authentication account, and then you will be able to keep up with all FSA and NRCS program information in the convenience of your own home!

## FARM STORAGE FACILITY LOAN PROGRAM AVAILABLE

Do you have any additional storage needs? Got a setup that needs a new leg? The Farm Storage Facility Loan Program (FSFL) may fit your needs. The program provides low-interest financing for producers to build or upgrade farm storage and handling facilities.

Participants are required to provide a down payment of 15 percent, with CCC providing a loan for the remaining 85 percent of the net cost of the eligible storage facility. Examples of eligible structures include permanent grain drying and handling equipment, hay storage, horizontal and upright silos, and cold storage facilities for fruit and vegetable storage. Loan terms of seven, 10 or 12 years are now available depending on the amount of the loan. Interest rates for each loan term are different and are based on the rate at which CCC borrows from the Treasury Department.

FSFL loans may now be closed using a partial disbursement and then a final disbursement option. The partial disbursement will be available after a portion of the construction has been completed. The final fund disbursement will be made when all construction is completed. The maximum amount of the partial

disbursement will be 50 percent of the projected and approved total loan amount.

The FSFL program helps to ensure that producers have adequate capacity to store their harvested production. Applications for FSFL must be submitted to the FSA county office that maintains the farm's records. An FSFL loan must be approved before any site preparation or construction can begin.

The FSFL program involves a \$100 per borrower processing fee. Loans less than \$50,000 can often be secured by the structure built or improved. Loans greater than \$50,000 are generally secured by real estate.

#### MAINTAIN YOUR GRAIN! (UNDER LOAN)

As temperatures rise with the impending spring season, producers are reminded to check the quality of their stored grain since spring is often when maintaining quality can be difficult. Quality problems can quickly affect grain value. Producers with marketing assistance loans and using farm-stored grain as collateral are responsible for maintaining the quality of the commodity for the term of the loan.

The Commodity Credit Corporation (CCC) is not responsible for any quality loss. Producers are also responsible to ensure payment is received prior to feeding or selling any commodity under CCC loan. County offices will be conducting spot-checks over the next several months to verify that the quality and quantity of the loan collateral is being maintained by the borrower.



#### 2008 SURE SIGNUP GOING ON NOW

You may remember that the spring of 2008 was a VERY wet season. If you suffered a crop production loss due to the wet weather, or any other natural disaster during the 2008 crop year you have the opportunity to sign up for the Supplemental Revenue Assistance (SURE) Program. #### ATTENTION! PLEASE READ IF YOU RECEIVED MONEY FROM OUR OFFICE IN 2009!

We would like to remind producers who received payments and benefits from FSA or NRCS in 2009 or who will receive benefits in 2010 of the Adjusted Gross Income (AGI) compliance requirements. USDA has a Memorandum of Understanding with the IRS to establish an electronic verification process for verifying compliance with AGI provisions for farm programs.

If you signed a <u>CCC-926</u> certifying AGI compliance in 2009 or 2010, you will need to complete a CCC-927 (or CCC-928 for entities) which authorizes CCC/FSA to share program participation information with IRS. Signing these forms also allows IRS to use and disclose certain tax information to CCC/FSA for AGI compliance verification purposes.

Program participants are required to:

- 1. Complete the CCC-927 and/or CCC-928.
- Mail the completed forms:
  -directly to IRS at the address specified on the forms
  -within 60 calendar days of the signature date

\*Completed CCC-927's and CCC-928's will not be accepted or retained in any FSA office.

Participants that choose not to submit a completed CCC-927 and/or CCC-928, as applicable will be determined noncompliant with AGI limitations for the 2009 and 2010 crop years and program benefits will not be earned.

<u>AGI explained in VERY simple terms:</u> If you received money from our office, you must sign and return this form to the IRS. If you don't return this form to the IRS timely, you will be required to refund ALL of your payments for the applicable year!

Please stop in the office to pick up one of these forms. Because of program rules we are unable to mail them to you!

#### TECHNICAL ASSISTANCE AVAILABLE

Kenosha County Land & Water Conservation staff is available to provide technical service and conservation planning assistance to landowners and units of government to help them to find solutions to land and water resource problems. We assist land-users with conservation systems that reduce erosion, improve soil and water quality, improve and conserve wetlands, and improve pasture conditions. In general, we will first assess any sources of erosion or pollution with the landowner and draft suggested solutions. If the landowner decides to install a conservation practice(s), the conservation staff will supervise the design and construction of the project and certifies it upon completion.

#### COST-SHARE AVAILABLE

Kenosha County Land & Water Conservation has costshare money available for landowners interested in applying general conservation to their land. So don't hesitate to call our office at (262) 857-1895 and find out if your projects will qualify for cost-share through the Soil and Water Resource Management Program. Costshare dollars are available to landowners who implement soil and water conservation practices that reduce soil erosion/sediment delivery, and that reduce non-point source water pollution. A seventy-percent cost share may be provided as an incentive payment to landowners for a variety of approved practices that protect water quality. #### NUTRIENT MANAGEMENT PLANNING

Current rules require all farmers who mechanically apply manure or commercial fertilizer to cropland (not just livestock operators) to have a nutrient management plan (NMP). Nutrients include nitrogen, phosphorus, and potassium from manure, legumes, organic byproducts, and commercial fertilizer.

Kenosha County Land & Water Conservation has a cost-sharing program for landowners interested in preparing a nutrient management plan. The program offers a flat-rate payment of \$7 per acre per year for a four year period (\$28/acre total), as available. The lump sum is given up front. Once a NMP is in place, by law, a farmer needs to update it annually. The update can take the form of an annual checklist submitted to DATCP and the County Land Conservation Department as a way to certify that the NMP complies with Wisconsin's NRCS 590 standard. It is important to note that all landowners who accept cost-share must agree to comply after the 4 year contract period and continue the practice as long as the land is farmed without any additional cost-sharing for this practice.

#### Reduce your use of hazardous household and garden products by choosing safer, less-toxic products.

Avoid household products with hazardous ingredients, or handle them with extreme care. Many toxic ingredients in paint thinners and drain cleaners, for example, can contaminate water sources.

Use only enough of the product to get the job done. Never dump hazardous products down drains, the toilet, or near flowing water, ponds, or lakes. Do not dump them on the ground. Use natural and less-toxic household products whenever possible.

Instead of:	Use
Air freshener	A small dish of vinegar or lemon juice set out in a warm area
All-purpose cleaner	One quart warm water, 1 teaspoon liquid soap, 1 teaspoon borax, and 1/4 cup vinegar
Bleach	Borax
Carpet cleaner	To neutralize odors, sprinkle the carpet with a mixture of one cup borax and 2 cups cornmeal or use baking soda. Let stand 1 hour before vacuuming.
Chlorine scouring powder	Baking soda
Detergent	Simple soap or phosphate-free detergent
Disinfectant	Ammonia
Drain cleaner	Plunger, followed by a handful of baking soda and a half cup of vinegar. Cover and allow to sit for 15 minutes. Pour in 2 quarts of boiling water, and the clod should disappear.
Floor cleaner	Mop floors with a mild soap solution or 1 cup vinegar mixed with 2 gallons of water. Linoleum floors can be polished by

Instead of:	Use
	mopping with skim milk. (No, it doesn't smell.)
Furniture polish	On unfinished surfaces, use natural oil such as almond or olive oil. On finished surfaces, dust with a damp cloth and wipe dry.
Glass cleaner	Two tablespoons of vinegar to 1 quart of water.
Grease remover	Baking soda paste
Mildew stain remover	Vinegar solution
Mothballs	Cedar chips
Oven cleaner	Pour salt on fresh oven spills, and scrape the residue off when the oven cools. Ammonia can be applied t tough stains. A pumice stick, available at many hardware stores, will also work.
Pest control	Make chili powder packets to keep ants out of your kitchen.
Stain remover	Cornstarch paste
Surface cleaner	Use a vinegar and salt mixture
Tile cleaner	Scrub areas with baking soda and a toothbrush
Toilet bowl cleaner	Baking soda or borax
Window cleaner	Mix 1/4 cup of white vinegar or 2 tablespoons of lemon juice and a quart of warm water.

#### **Common Stains**

**Blood:** First, soak or rub in cold water until stain is almost gone. Then, if fabric is washable, launder in warm water and detergent. On non-washable materials try a little borax or hydrogen peroxide to get the last traces out. Once blood stains set, they are difficult to remove, but a warm solution of trisodium phosphate will sometimes work on cotton or linen.

**Coffee, tea:** These are easier to remove if no cream was involved. Treat as non-greasy stain with cold water. If cream was involved, follow directions for combination stains, treating first with water, then detergent. A solvent may be necessary.

#### High Risk Period for Manure Runoff

As the sun reappears and turns temperatures to spring-like conditions producers should tune an ear to weather forecasts to prevent runoff and nutrient loss. Producers are advised to adhere to the following four steps to prevent runoff:

- During periods of snow melt or rain on frozen soils, producers who must haul manure from barns should stack it in areas where the potential for runoff or ground water infiltration is low.
- Farmers who daily haul manure should contact the local Land Conservation Department to identify safe stacking sites that have minimal potential to runoff into either surface or ground water.
- Producers who have lots or facilities with bedded pack systems need to be cautious about spreading manure during high risk periods.
- Identify fields that are away from streams, lakes, and have minimum risk of manure runoff to surface or groundwater.

#### HAVE YOU SEEN THIS BEETLE?



Adult Emerald Ash Borer

Infestations of the Emerald Ash Borer have occurred in the counties of Milwaukee, Kenosha, and Washington. These infestations have initiated quarantines in most of the southeastern Wisconsin counties, including Racine. The quarantine places a restriction on the import of firewood onto county lands. The intent is to slow the movement of the pests via human assistance. If you have noticed two or more of the signs or symptoms below please call 1-800-462-2803.

- Bullet shaped metallic green adult beetles from June to August (see above)
- S-shaped tunnels under the bark created by larvae feeding
- Cream colored flattened (full grown) larvae boring under the bark
- D-shaped holes in the bark where adult beetles have emerged
- Dieback of the upper and outer tree top

#### **Gypsy Moth Spraying**

With the spring and summer months approaching its time to keep an eye out for gypsy moth caterpillars and egg masses; caterpillars usually emerge May – July, while egg masses are present from August – May. If you notice any infestations please contact the DNR or the Racine County Land Conservation Department and we will investigate the situation. If requirements are met you may be placed on the 2011 spray list. A spray area for 2010 has already been selected and is scheduled for spraying in May or June. 




