- Nursing and Environmental just dealt with Salmonella outbreak. Had 70 probable cases with 35 of those confirmed. Team is working on an After Action Report.
- Home Visiting Team hired a new nurse working with our Parents As Teachers (PAT) home visiting program
- Grants Life Course Initiative will be doing a mid-year oral presentation to the funders.
- Submitted a proposal to expand our Early Childhood Comprehensive System community pilot project.
- Adult Death Review Team model was selected to present at the American Public Health Association poster session
- Receiving funding to mentor Cudahy County Health Department as they move toward accreditation
- Submitted a letter of commitment for funding in order to collaborate with our Division of Aging on a dementia friendly community
- Have 2 public health nurses to hire one for Nurse Family Partnership and a school nurse
- Marilyn Huntoon retired and Nancy Reeves has 23 days until her retirement. One
 person on maternity leave and a grant employee moved to a county levy position in
 Planning and Development
