#### SUPERVISOR REPORTS

Supervisor Elverman stated the pavilion rentals in the county parks will be raised \$10 next year. The old 60<sup>th</sup> St communication tower is gone. The KCAB restoration is nearly complete; they will be going through the punch list on December 19<sup>th</sup>. The golf courses have been closed since about November 5<sup>th</sup>. There are several projects being done at various county facilities. The vacant HVAC position has been filled and they are hiring for a custodial position.

Supervisor Hallmon stated the Human Services Committee meeting was cancelled due to a lack of agenda items. They will meet in January when Doug Bartz, the Job Center Manager will share some interesting and insightful information; he encourages all supervisors to attend. Supervisor Hallmon will be speaking under Supervisor Comments at the next meeting.

Vice-chair Breunig stated the dam which was removed from Bong last summer is now being rebuilt by the DNR. They are trying to get some grant money to dig some of it out so they can refill it next summer.
