### May 3, 2016

The **Regular Meeting** was called to order by Chairwoman Breunig at 7:30 p.m., in the County Board Room located in the Administration Building.

Roll call was taken.

#### ANNOUNCEMENTS OF THE CHAIRWOMAN

Chairwoman Breunig reminded the new supervisors to contact Donna Esposito for their badges if they haven't done so already. WCA survey on the desks should be filled out and returned to the clerk. She also reminded everyone that May is Mental Health awareness month

#### SUPERVISOR REPORTS

Supervisor Dodge stated that Brookside Care Center is in his district and he often attends the Brookside Trustee Meetings and they asked him to read into the record a letter which was placed on the supervisor's desks regarding a generous donation by Joseph Bertelle. \$228,005.34 was donated to Brookside to be used solely for Activities and the benefit of the residents of Brookside Care Center. This money has been placed with the Kenosha Community Foundation. Brookside Care Center will work with the foundation. Brookside Trustees and Kenosha County Division of Financial Services will work closely to insure that the funds are protected and that Mr. Bertelle's wishes are carried out. He thanked Mr. Bertelle and his family for this generous donation.

Supervisor Elverman stated Public Works/Facilities had their first meeting with the new members. The Highway Department roof is 50% done and should be completed by the end of May. The ash borer work is complete but there is still clean up to be done. The White Course at Brighton Dale has been named in the top 8 out of 800 golf courses in Wisconsin. This is a huge honor. The generator in the Public Safety Building is aged in and in need of replacement. The fire alarm system in the PSB is also being redone which is in the budget this year. There is an I-beam problem in the exercise yard at the Detention Center. Temporary parking has been set up at Brookside and irrigation on the Blue Spruce Golf Course is ongoing. They are working with consultants with the Kemper shoreline study to come up with a plan for that.

Supervisor Goebel stated the Human Service Department presented a report and answered questions regarding the Mental Health Study. The report has been emailed to all the supervisors. The Mental Health Crisis will be an ongoing project for this board and the community for two years or longer. He also thanked the supervisors who were able to attend.
