- Mark stated that we have recovered as a region and are advancing in job growth.
- ➤ Wage loss throughout the Counties but not sure of the reasoning.

WIOA Update: Mark Mundl, Racine County Workforce Solutions

- **Business Solutions Performance:**
 - o Mark is on a committee regarding performance measures − 3 were written in the law but 2 have been selected; market penetration and repeat business customers.
 - o Business Solutions is transitioning from SalesForce to Job Net Business for data to be collected.
 - o Performance will be officially measured as of 2020.

Other Items as Allowed by Law:

- ➤ TechHire Update:
 - o First cohort is currently in session with 9 young adults that will graduate in September.
 - o If your company is interested in hosting an IT Intern for 1 week, please connect.

Matt Waltz asked if there was any statistics on the students – transportation, etc... and Mark stated that he does he have information and can get that information pulled.

Dr. Bryan Albrecht said that it would be helpful to find out what the objectives are since it's such a short period so that the businesses know what the students should get out of it. Mark said that depending on WIOA eligibility, the internship could be extended.

- > Dr. Bryan Albrecht stated that he would like to give an update on Gateway and hopes to do a presentation in the near future to the Board on new and exciting things happening at GTC:
 - o 1,009 students that graduated in May
 - Elkhorn is expanding Engineering Program
 - o Culinary Arts will be available in Elkhorn
 - o Working with the Real School via the iMET Center
 - Automated Manufacturing Systems Program is being added to the iMET Center
 - o INSPIRE Center will be opening in Kenosha
 - o Construction to begin on new emergency vehicle track
 - o Gateway Promise Program has 150 students at no costs
 - o Current fundraising goal is 3 million and have currently raised 2.2 million

Thanks to Doug, Mark and Karen for handling the RFP process. It's a hard process but everyone did a wonderful job.

Local Elected Official Comments:

➤ Walworth County Board Chair Nancy Russell said that 2 resolutions have been passed in Walworth County. Hoping to get that through DOT and get that started. The budget process will begin in August.
