### **CCS (Comprehensive Community Services)**

We continue to review service arrays within CCS. The previous Medicaid Newsletters addressed Screening and Assessment, Service Planning and Service Facilitation, and Diagnostic Evaluations. We have also reviewed Medication Management, Physical Health Monitoring, Peer Support, Individual Skill Development and Enhancement and Employment Related Skill Training and Individual and/or Family Psychoeducation. The next service array to be reviewed is Wellness Management and Recovery/Recovery Support Services.



Wellness Management and Recovery is a very robust service array, including empowering members to manage their mental health and/or substance abuse issues, helping them develop their own

goals, and teaching them the knowledge and skills necessary to help them make informed treatment decisions.

Recovery support services also include emotional, informational, instrumental and affiliated support.



Services include:

- Behavioral tailoring
- Relapse prevention
- Development of a recovery action plan
- Recovery and/or resilience training
- Treatments strategies
- Social support building
- Coping skills
- Increase engagement in treatment
- Providing assertive continuing care

Services can be taught using motivational, educational and cognitive-behavioral strategies.

### **Other Medicaid Programs**

- ❖ Community Support Program (CSP) had an on-site review for DQA Recertification. The program received no citations! CSP is recertified for the maximum allowed time, 2 years! Congratulations to all the staff that worked so diligently to achieve this accomplishment!



- ❖ Crisis Intervention Program is getting Medicaid Training! This is a very exciting endeavor. All Crisis staff will be trained in Medicaid billing/documentation for Crisis services in 2019. The first training was held in December 2018 and was very-well received!

### **Targeted Case Management Information**

Q: Can Medicaid be billed for ongoing monitoring and service coordination even though there was no Medicaid billing for an Assessment or Plan of Care?

A: Yes, Ongoing can be billed to Medicaid even though the

Assessment and/or Plan of Care was not. Case Management Handbook indicates:  
*"Providers need not have billed Wisconsin Medicaid for either an assessment or a case plan prior to billing for ongoing monitoring and service coordination. Providers meet Medicaid requirements if the assessment is complete and a current case plan meeting the standards for Medicaid reimbursement is in the recipients file".*

Programs have been scheduling refresher training with Robyn, but please keep the requests coming! Robyn will meet with you as often as is necessary to feel comfortable with the work being done and billing appropriately.
