Motion by: Arrington **Seconded by:** Clark **Approved:** unanimously Supr. Clark stated that there has been a lot of discussion regarding this both here and at Finance. Supr. Arrington said we support the Sheriff and want him to be successful. He asked the Sheriff to keep the Committee updated. Sheriff reported that he did have an updated date of completion that is now projected for the end of December, however, officers would still not be ready too soon. Supr. Jackson asked when the resolution was passed for the renovation and if it was perceived that officers would be needed. Sheriff replied that the resolution was passed in May and that they did report that additional officers would be needed. Jackson said we must think ahead and believes there is a need for additional officers. She asked if additional officers after this 10 would be needed. Sheriff replied yes and that we are generating revenue now so we can get people started early. Jackson asked about the overtime. Sheriff said the problem is with the overtime procedures Downtown. An emergency was put in place. Jackson asked if this is in violation of the union contract. Sheriff responded no, he can declare an emergency. Jackson asked if this would be addressed in future negotiations. Sheriff replied that they would try.
