<u>CCS (Comprehensive Community</u> <u>Services)</u>

The CCS program has many providers and staff that all work together to serve the consumers of Kenosha County. Kenosha CCS has 27 agencies, many have additional programs within, and over 350 active staff members providing psychosocial rehabilitation services across the lifespan.



The role of the service facilitator is to coordinate services. This includes changes to amounts of hours, specific workers, service changes, etc. Additionally, a major 'job' of the service facilitator is to communicate those changes with the client/family/team. Please make sure that you are directing all service conversations with the Service Facilitators.



The CCS program has many rules and requirements per DHS 36 and Medicaid. A couple of very important rules that we need to adhere to are getting Clinical Supervision and/or Clinical Collaboration hours as faceto-face hours are provided to consumers. Please make sure to monitor your hours and ensure that you are getting the supervision or collaboration needed to meet requirements: 1 hour of supervision for every 30 clocked face-to-face hours or 1 hour per week.



Additionally, training is an essential part of providing quality services to consumers. There are many training opportunities offered throughout Kenosha County to our CCS Providers in order to ensure adherence to this requirement. Please make sure your staff are trained early and often. The sooner the ongoing training requirement is met, the sooner you can focus on other important tasks.

Targeted Case Management (TCM)

Q1: Can we bill for siblings who each need TCM?

A1: We are not able to bill for siblings receiving TCM services. TCM is meant to be provided to meet the needs of the entire family through the identified client. The only exception to this rule is for clients identified with the target group for Birth to 3.

Q2: Can Targeted Case Management and CLTS be provided to the same client?

A2: TCM cannot be provided to a client when any other form of case management services are provided to the same client during the same time. This includes CLTS, CSP, or CCS.
