	Julia Robinson – Was a Pre-Med/Pre-Psych major in college. Worked as an EMT in the Emergency Room. Has a Masters in Psychiatric Social Work, worked with domestic violence, sexual abuse, traumatic brain injury at the VA, homeless, chemically dependent, mentally ill. Clinical Director of Psych Department for Alexian Brothers Psych System. An alderman in Kenosha for 10 years as she wanted her community to have a voice.
