Health Officer/Director's Report

Disease Investigation and Contact Tracing caseloads have gone down throughout December. Death curve is still too high. Preparing for another spike in February. Still in critical category. We are maintaining 100% disease investigation/contact tracing.

The demand for testing is low, but it is still very much needed. The National Guard is now realigning their efforts toward vaccination, so we don't have them for testing. Modern Apothecary's last day is January 19. UW-Parkside's testing ends at the end of the month. Funding at the state level has decreased for the Fire Department and the Kenosha Community Health Center to remain in the testing game. Please check the Kenosha County HUB Website as this is updated daily.

Police and Fire will be included in Phase 1a starting next Monday. This is for public facing police and fire after we get through most of our 1a population. Our county HUB website lists more partners that are coming on as vaccinators. We need to stress that we are only in 1a right now. Go to our website to register for the vaccine. There is a vaccine ticker there that shows percentage of Kenoshan's vaccinated based on place of residence. Under 3,000 have been vaccinated to date. For those that wish to volunteer, there is a link to WEAVR (Wisconsin Emergency Assistance Volunteer Registry) on our website. The National Guard will be coming to Kenosha County to observe our vaccine clinic and learn from us. 70% of our EMT's are vaccinated. Questions as to why other states are ahead of us in vaccine phase. Its an issue of supply and demand. At the local level, we can only speak to the amount of vaccine that we receive. Some rural counties in Wisconsin have a smaller population and have their 1a population already vaccinated. We've been working with Aurora and Froedtert South and have sent out their registration link to all 1a providers. Primary care providers can sign up through the CDC to be Covid vaccine providers.

The vaccine is very safe and effective. We have seen very little reaction to the first dose. After the 2nd dose, side effects seem to last for a maximum of 24-48 hours. If someone had Covid, they need to wait 3 months to get vaccine. It won't hurt them to get the vaccine, but they have 3 months of immunity and would like to give the vaccine to someone with no immunity.

Our JIC and PIO are working on messaging, info graphic, FAQ's, videos on the vaccine.

Several different planning efforts are going on to make sure we get 1b. There is much logistical coordination involved in this phase. We are still waiting for Federal funding for vaccine planning.

We are hiring two new Public Health Strategists. One of the positions will be a full-time masters level person who will focus on health equity both internal and external. Our Board of Health By-Laws passed this past week. We will be following these moving forward. Will be filling the vacancy we have on the board. Working on obtaining a new electronic medial record. We're scoring top 3 vendors.

	Our EBL's (elevated blood levels) have been high. Pediatricians should be testing blood lead levels before	
	the age of 3. Post pandemic we are preparing to see higher levels of substance abuse. On our health	
	department website, we need to get updated pictures and bios of our members.
