Meeting Called to Order:	8:00 p.m. by Chairman William Michel II	

Citizen Comments: Capt. Apker explained that he was late because he thought the joint meeting started at 6:45 p.m. He asked to speak regarding the ordinance change to eliminate vacation payouts. Apker reported that there are 23 sworn non-reps. All have taken oaths and have arrest powers. We are not in the private sector. For wage comparison to the private sector, we are not close; however, with benefits we are comparable. Comparisons are made when it is convenient. We are all Deputy Sheriffs with different ranks. We can be called upon at any time. The tactical team can be called out for nothing. Deputies can get time and a half; we get nothing. When you say there is not much difference between sworn and non-sworn non-reps, he disagrees.

The Sheriff came last year and asked us not to take a raise until December; we accepted this and gave money back to the County. We were commended for our budget yet you nitpick over this. There are more vacation payouts at this level due to the length of employment and more allowable vacation time. Of course we may want the benefit of enhancing retirement benefits.

Deputies need supervisors. A few years back Reidl gave the option to go with non-reps or Deputy Sheriff's. This year we did not take a raise in July like the deputy sheriff's; we waited until December. We planned this year's vacations expecting the payout option. If we are suppose to take remaining vacation this year it is probably not possible. Hopefully pay can at least be given for this year. Singer & Michel said that this is what was agreed.

Without advising sworn non-reps first, Apker also stated that Finance called the State and told them that income reported for previous years included vacation payouts and that they were going to change the policy. This resulted in adjustments going back years that significantly affected retirement benefits without prior notice. This is wrong.

In closing, Apker stated that he realizes the budget is tough. The Sheriff is giving back over 1 million dollars. If federal inmates were lost, they would have to make up 2.5 million. Cuts would then be needed everywhere and then this could maybe be looked at. Now there is not so much of a crunch time. You are coming after us because you can.

1) An Ordinance to Repeal and Recreate Section 9.101.123 of the Kenosha County Ordinances Prohibiting Smoking in Public Places and Places of Employment Motion has been sectored by Singer

Motion by: HaasSeconded by: SingerApproved: unanimouslyMichel reported that he spoke with Corporation Counsel about this and the language change justbrings us into conformity with State of Wisconsin language. This creates a local ordinance that spellsout according to State Statutes so deputies can write citations for the County. Revenue would then cometo the County instead of going to the State. Supr. Frederick commented about the exceptions listed suchas reasonable distance, retail tobacco store, pipes, etc. Michel replied that this is the language the Statehas to accommodate stores whose business is selling these products.

Any Other Business Allowed by Law: Frederick stated that he would like the matter looked into about Apker's remarks that statements were issued with adjustment figures affecting retirement benefits. Michel said he would look into this.
