President's Comments	Dr. Gerlach introduced new Board of Health member Ola Baiyewu. Each member of the group introduced themselves. (00:00:28 – 00:04:22)	
Health Officer/Director's Report a. IGA with City of Kenosha	<p>Tammy Capito, CFO Human Services, reported on recent changes to the Intergovernmental Agreement with the city of Kenosha which involves changes to the city/county contract. In 1992, the city health department and the county health department merged into one to save costs. Fiscal does a cost allocation every year that charges city residents above and beyond what the tax gets charged to them for the services that they use. Last week the County Board approved phasing this out. Starting in 2023, the city will pay a lump sum of \$700,00 and this will go down \$100,000 each year until reaching zero in 2029. Once at zero, the city will no longer pay for the county health department. It will be part of tax levy.</p> <p>Moving forward, Jen would like to further develop communication structure with the city as the majority of the people we serve are from the city.</p> <p>Jen reported that Covid numbers remain extremely low. Expect a possible bump in numbers post spring break. Recommendations for this summer are that outdoor activities are best as well as good Covid practices.</p> <p>Have started providing 4th booster doses for those 50+ immune compromised. Recommendation is 5 months between 1st booster to the next. The community has been coming to the health department for this.</p> <p>Jen gave a background overview for Ola about how the Board of Health functioned in the past and her current vision of this board being an involved advisory group. Would prefer PowerPoints, reports, etc. emailed out ahead of time. This reading can be done before the meeting.</p> <p>Roger Perez is concerned about what we can do to help the new Hispanic population coming to Kenosha.</p> <p>The county is going through a wage study. We have spent a significant amount of time updating job descriptions.</p> <p>Schools reaching out to us as they are seeing an increase in vaping. One of the high schools reached their hundredth case. Would like us to partner with them on addressing this issue.</p> <p>The health department has had a “huge win” with the Kenosha County Detention Center. We will now be able to distribute Narcan to every inmate upon release. We are moving forward with training police officers on Narcan.</p> <p>Our 2021 Annual Report is almost complete. This will be on the October Agenda for approval.</p> <p>Working with architects on our new building slated with a move in date of 2024. Drawings were submitted to the architects. Blueprints should come to us by the end of this month. Our Executive Team recently toured Kenosha Human Development Services to learn of their programs/services as well as see their layout.</p> <p>Meetings have begun with our consultant for the Community Health Assessment (CHA). Will discuss this further at our next meeting.</p> <p>Looking to hire a GIS intern to help our Epidemiologist look at mapping for all our programs. Working toward an internal dashboard for performance measurement and improvement with the goal of an external dashboard for all our programs and services down the road.</p> <p>Our Asthma Program has sent out letters to all students in KUSD to garner more help for asthma numbers. We are one of the higher counties in the state with asthma rates. The state funders have changed the program to fee for service.</p> <p>Our Environmental section now inspects all tourist rooming houses (TRH). This is a collaborate with the Kenosha Visitor's Bureau. Holding a food handlers' class in June.</p> <p>Our Home Visitation Program has gone through a rebranding and is now referred to as Bright Family Beginnings. In addition, our HUD program is in the process of rebranding to the Lead Poisoning Prevention Program.</p> <p>Samantha Kerkman has been elected as our New County Executive. John Jansen, Director of Human Services has met with her to represent each of our divisions top 3-5 priorities for the next year. Open to a meet and greet with the new County Executive and County Board members. Suggestion was made to meet with the Aldermen as well and it is important to have two separate meetings.
