Communicable Disease Cases – Gillian Redmond	 Established an MOU with Aurora Kenosha Hospital to enable our Kenosha Overdose Response Initiative (KORI) team to receive demographic data on their Emergency Department (ED) overdose survivors who are discharged from the ED. Preparedness Supervisor assisting with Milwaukee RNC July 2024 planning; including participating on Medical Countermeasure and Surveillance workgroups. Department of Agriculture trade and Consumer Protection performed an audit of our retail program. The audit reviews policies and procedures, training program, communications with facilities and inspection protocols and code knowledge. This audit may take several months to complete. The Lab received the new instrument enabling the clinic to screen for fentanyl prior to administering vivitrol to the Medication Assisted Treatment (MAT) clients. This new instrument also automates our urine collection process enabling UA results more rapidly for DCFS, Treatment Court, Professional Services Group and several other agencies who require UA positive results to enter programs.
