Frequently Asked Questions

CTH E Shared Use Path WisDOT ID #3766-00-71

1. What is the trail cross section?

a. The trail will be a 10' wide asphalt path with turf shoulders.

2. What outside parties will be involved on the project?

- a. DK Contractors is the general contractor for the project and has a variety of subcontractors performing some of the work.
- b. KL Engineering has been hired by Kenosha County to perform the construction administration services.

3. What is the project timeline?

- a. The project is anticipated to begin March 23rd, weather dependent.
- b. The project completion is currently anticipated in early summer.

4. What does the project involve & timing?

- a. The project will start with survey, erosion control, and clearing and grubbing.
- b. Trail construction will then follow (excavation, stone, asphalt)
- c. Peripheral to the trail itself will be the following (some during, some after):
 - i. Bicycle/pedestrian improvements at the RR crossing
 - ii. Intersection improvements (addition of a pedestrian crossing)
 - iii. Signing & marking @ the intersection and RR crossing

5. How will roadway traffic be handled for this project?

- a. The project will largely be built from the trail itself, with periodic shoulder closures for deliveries and removals.
- b. The intersection improvements at STH 32 and CTH E will have hard lane closures, but traffic will be maintained through all work (no detours).
- c. Access to residential driveways (and the fire station) will be maintained throughout the project. When work is being done for the trail directly in front of your yards, the contractor will alert you (grading, stone placement, pavement).

6. I have some decorative items at the end of my driveway—do I need to move them?

a. Yes, please relocate them for the duration of the construction if they are located within the roadway Right of way. Silt fence will be placed within the R/W and behind the limits of construction. All personal property within the area between the silt fence and road should be relocated. For reference, the R/W is approximately ~50' from the edge of the roadway.
