WHEN WILL THE PROJECT START?

» Phase 1 will begin spring 2020, Phase 2 is scheduled to begin mid-to-late spring 2020

WHEN WILL IT BE FINISHED?

» Phase 1 and Phase 2 are scheduled to be completed late fall 2021

WILL I ALWAYS HAVE POWER, CABLE, AND NATURAL GAS TO MY HOUSE?

CAN THE POLICE, FIRE, AND EMS ALWAYS GET TO MY HOUSE?

» Access to all businesses and residential homes for first responders will be maintained at all times throughout the project

WILL MY DRIVEWAY ALWAYS BE OPEN?

» Limited impacts will occur during removals and paving operations and the contractor will notify property owners prior to any impacts

WHAT ABOUT WINTER SNOW REMOVAL?

» Kenosha County will maintain snow removal on the county roads during the project

WHAT ABOUT NOISE AND DUST?

» Businesses and residents should be aware that there will be noise and dust associated with work and steps will be taken to minimize these effects

WILL THERE BE NIGHTTIME WORK ASSOCIATED WITH THIS PROJECT?

» Yes, there will be some nighttime work associated with this project

WILL THE CONTRACTOR WORK WEEKENDS?

» The contractor's schedule will utilize weekend work to make up for rain days or to catch up on operations that are behind schedule

WILL THE ROAD BE CONCRETE OR BLACKTOP?

» The road will be reconstructed with asphalt

WILL THERE BE MORE INFORMATION MEETINGS?

» Public and in-person meetings for transportation projects are temporarily suspended to help stop the spread of COVID-19 (coronavirus). Kenosha County remains committed to ensuring you are able to get up-to-date project information, and we welcome your comments, questions, and feedback on this project

WHAT IS THE DETOUR ROUTE FOR ANY CLOSURES?

» I-94 North-South to WIS 158 to WIS 31

CAN PEOPLE ALWAYS GET TO MY BUSINESS?

» Yes, access to businesses will be maintained throughout the project

WHAT ABOUT DRAINAGE?

» The area of this project has a high volume of surface and subsurface drainage through to the Pike River and Kilbourn ditch. The project will enhance the existing drainage through the addition of stormsewer pipes and underdrains and will preserve the existing drain tiles in the area. This project will also be adding a regional stormwater detention pond west of the Canadian Pacific Railroad to provide storage of stormwater during large rain events

WILL MY YARD GET FLOODED?

» The project will not block drainage paths but if existing facilities are not capable of carrying the water during heavy storms, some flooding may occur

WILL THERE BE MUD IN MY YARD?

» Within the easements negotiated by Kenosha County Real Estate, there will be earthmoving operations which could generate mud. This will be kept within the project limits by silt fence and other erosion control measures

WILL THE WATER DRAIN AWAY FROM MY PROPERTY?

» Yes

WILL I BE ABLE TO MOW MY LAWN UP TO THE ROAD WHEN IT IS FINISHED?

» Yes, upon project restoration, you will be able to resume mowing

WILL I BE ABLE TO USE MY RIDING MOWER TO MOW THE DITCH LIKE I DO TODAY?

» The ditches will be sloped at a maximum 3:1 slope to allow mowing

WILL MY DRIVEWAY BE WHERE IT IS TODAY?

» In general, driveways on the south side will be in the same location. Driveways on the north side will be shortened. There are some properties whose access will be modified like the driveways east of the CPR on the north side of the roadway where the Frontage Road is being realigned to fit with the new roadway

I HAVE A BLACKTOP/CONCRETE DRIVEWAY, WILL YOU BE FIXING/MATCHING WHAT I HAVE WHEN IT IS DONE?

» Yes, the project will replace your driveway access in kind IS THERE A MEDIAN CROSSOVER AT EVERY DRIVEWAY?

» No

WHAT WILL THE SPEED LIMIT BE WHEN IT IS DONE?

» The speed will resume to what is was prior to construction

WHAT IF I HAVE A SPECIAL DELIVERY COMING TO MY HOUSE, CAN THEY GET THERE?

» The project will maintain all access to properties. That said, there may need to be specific directions on which direction to come from during specific operations. This will be coordinated through the public involvement team

WHAT ABOUT BUS SERVICE?

» The project team will work with the bus company to ensure service is maintained
