Notice is hereby given that sealed bids for the Kenosha County Bridge Rehabs in Kenosha County will be received until 10:00 a.m., local time on the 19th day of February, 2021. Unsealed bids will not be considered. All proposals containing bids and required bidding documents shall be placed in a sealed envelope, with bidder's name and address, project name, and date of the bid opening plainly written on the envelope containing the bid. The sealed envelope should be mailed to: Westbrook Associated Engineers, Inc., 619 E. Hoxie St., PO Box 429, Spring Green, WI 53588 on or before February 19, 2021 prior to 10:00 a.m. No bids will be accepted after the deadline. Due to Covid-19 guidelines bids will not be opened publicly. Westbrook Associated Engineers, Inc. will open all bids received at **10:00 a.m.**, local time on **Friday, February 19, 2021**. After the opening Westbrook Associated Engineers, Inc. will email an As Read / Apparent Bids List to all bidders by **12:00 p.m., Monday, February 22, 2021**.

All **bidders must file** a "Bidders Proof of Responsibility Form" with the Kenosha County Highway Commissioner on or before 3:00 p.m. on **February 10, 2021 (Form PA-10)**.

Questions received after this deadline or via telephone will be rejected. Answers to the received questions shall be sent via email to all Plan Holders by 4:00 p.m., February 12, 2021.

A certified check or bid bond payable without condition to Kenosha County in an amount not less than five percent (5%) of the bid shall be submitted with each bid as a guarantee that if the bid is accepted a proper contract and bond will be executed and filed within ten (10) days after the acceptance of bid. If such bidder fails to execute and file such contract and bond, the amount of the check or bid bond shall be forfeited as liquidated damages.

No bid shall be withdrawn after the opening of bids without the consent of the Kenosha County Department of Public Works for a period of sixty (60) days after the time of opening bids. Each bidder agrees upon submission of bid that if the same be accepted within said time period, he shall be bound by the terms of acceptance hereinafter contained.

Contract award shall be made based on the lowest responsive and responsible bidder. The Kenosha County Department of Public Works reserves the right to reject any or all bids received, or to accept any bid which may be most advantageous to, and in the best interest of Kenosha County. Each successful bidder will be required to furnish a satisfactory performance bond in the sum of the full amount of the contract.
