WHEN WILL THE PROJECT START?

» The project is currently in the design phase with an anticipated start date of summer 2021

WHEN WILL THE PROJECT BE COMPLETED?

» The project is scheduled to be completed winter 2021

WILL I ALWAYS HAVE POWER, CABLE, AND NATURAL GAS TO MY HOUSE?

» Yes, your utilities will be maintained throughout the project

WILL THE COUNTY HIGHWAY C AND COUNTY HIGHWAY U INTERSECTION PROJECT BE UNDER CONSTRUCTION AT THE SAME TIME?

» No, these project will not be constructed concurrently

WILL MY DRIVEWAY ALWAYS BE OPEN?

» Limited impacts will occur during removals and paving operations and the contractor will notify property owners prior to any impacts

WHAT ABOUT NOISE AND DUST?

» Businesses and residents should be aware that there will be noise and dust associated with work and steps will be taken to minimize these effects

WILL THERE BE NIGHTTIME WORK ASSOCIATED WITH THIS PROJECT?

» At this time, work is not scheduled to take place overnight

WILL THE CONTRACTOR WORK WEEKENDS?

» At this time, work is not scheduled to take place on the weekends

WILL SCHOOL BUS SERVICE BE MAINTAINED?

» Yes, the project team will coordinate with the school bus companies to ensure there is not an interruption in service
