### Modern Roundabout Benefits

- Less potential for serious crashes (head-on and T-bone collisions are eliminated)
- Low travel speeds (less severe crashes result from lower travel speeds)
- Make the intersection safer for novice users
- Reduce the size of sight triangles needed for users to see one another
- Reduce travel delays by 13 to 23 percent

The Kenosha County Department of Public Works invites you to a public involvement meeting (PIM) to discuss the improvement of the County Y (22<sup>nd</sup> Ave.) intersection with County A (7th St.). This existing stop controlled intersection is proposed to he reconstructed as a single-lane roundabout.

The format of the meeting will be open house. There will not be a formal presentation. Attendees may stop in at their convenience and view exhibits, meet with project staff, ask questions and provide feedback. The exhibits will show the recommended alternative with needed real estate acquisitions and the proposed detour routes during road construction.

Kenosha County encourages property and business owners, interested citizens, and other stakeholders to attend the meeting and provide input.

## **Project Information**

Purpose: The purpose of this project is to improve the safety of the intersection and maintain acceptable traffic operations at the intersection.

Safety Concerns: The crash rate for this intersection is 1.41 crashes per million entering vehicles (2013-2017), which is significantly higher than the statewide average of 1.0 for similar rural intersections.

Proposed Improvement: The study team has analyzed the alternatives and has selected the single-lane roundabout for implementation.

Estate: right-of-way Real Permanent acquisition would he required to accommodate a roundabout at this intersection. Temporary grading easements would also be required to construct the improvements. Right-of-way needs will be on display at this public meeting and the County's real estate representatives will be available to answer questions you may have regarding the real estate acquisition process.

#### Oak Street **Pedestrians** » Pedestrians at the curb side look left for oncoming traffic before crossing Crosswalk: » Pedestrians within the ield to pedestrians crosswalk island area look right for oncoming traffic before crossing. **Maple Avenue** Maple Avenue Bicycles Bicyclists can continue » through the roundabout taking the travel lane, or Traffic circulates » may exit the roadway ONE WAY counterclockwise and use the crosswalk. in a roundabout **Oak Street** Yield to all traffic before entering roundabout!


