Citizen Comments

Michael Bell 3317 13th PI. came to share new evidence he discovered. In Oct. of 2019, during a visit to the house where the incident involving his son's death occurred, Mr. Bell found the bullet impact location. Mr. Bell had it processed by a forensics evidence technician from the Chicago PD, and the following day he contacted Sheriff Beth. DCI came down and also processed the site, at the direction of Sheriff Beth. Mr. Bell provided the Supervisors a packet including the letter he sent to Sheriff Beth, as well as a photo of the finding. The bullet impact location and the slug were sent for analysis, and the shape, diameter and depth match perfectly with the bullet that was taken from the Police Dept. Mr. Bell reiterated that forensics do not lie, and he pointed out that the results match the eyewitness statements, but are contrary to the police reports and subsequent depositions. Mr. Bell feels D.A. Graveley is a core problem, and believes he needs to stand down, and that Officer Albert Gonzales should be charged with 2nd Degree Intentional Homicide.

Announcements Of The Chairman

Chairman Esposito welcomed from Youth In Governance Victoria Desimoni from the Legislative Committee, and wished all the Supervisors and happy and healthy New Year.

Supervisor Reports

Supervisor Elverman reported from Parks - The day after Christmas Pets Golf had 85 golfers. The indoor golf simulator has been a big hit. They are preparing for tuning up the Clubhouses for next year, as well as the Milwaukee and Chicago Golf shows. On the revetment project for Kemper Center shoreline, design work is substantially completed and permits submitted. The permits are for five years, which puts us in a great position to search/apply for grants, as we would be ready to begin as funding became available. From Facilities, KCC Chiller Replacement is ongoing. \$260,000 was estimated, bid accepted was for \$253,000. Project should be completed by April. P&D remodeling is essentially complete. Anderson Arts Center is complete, except for landscaping this Spring. The Joint Services Evidence Area renovation bid documents were released on 10/31/2019, construction bids were received on 11/21/2019. The cooler/freezer bids are due on 1/7/2020. Construction scheduled for 2020. We have closed on the final property for a tower near KCAB, and now are in rezoning phase with the City. Facilities is currently putting together timelines for the remaining 2020 projects. From Highway - They have studied both short and long-term solutions for Highway W. The definite need for a short-term solution was identified. The initial projection was \$500,000, but is now expected to be under \$300,000 for the immediate need of 90 ft. to be done right away. This would open the road back up by March, which would give up to 5 years to come up with some long-term solutions for the section of W which is along the Fox River. Everything is on schedule for other Highway ongoing projects, Hwy S (both phases), Hwy KR, and Hwy F. Salt supply is good due to mild weather.

Supervisor Berg attended Kenosha Co. Veterans Council board meeting. Banquet is Sat. March 14; see him for tickets. They also have nomination forms for: Veteran of the Year, Lifetime Achievement Award, Auxillary Member of the Year, Veteran's Service Organization of the Year, and both Civilian and Business of the Year. Keynote speaker will be Mary Kolar, Secretary of WI Dept. of Military affairs.

Supervisor Nudo reported on Brookside's Board of Trustees. Both Brookside and Willowbrook are doing better than projected. Willowbrook is running at full capacity, and now has a waiting list.

While it takes awhile to hear a response from FEMA, it appears as though the homework our engineers did would work favorably to support our need. Other items that were discussed at the Feb 3 Public Works meeting: The chillers at KCC are on schedule with a targeted completion date of:4/1/20, Planning & Development remodeling is ongoing with a scheduled move in date of 2/14/20. From Facilities: Anderson Arts Center has a grand opening scheduled for Feb 22, featuring a new art exhibit. Invitations have been extended to the Supervisors. For the Ceremonial Courtroom, public and private grant funding is still being sought. A benchmarking phase will begin on February 17, requiring the courtroom to be closed for a short period of time. The Joint Services evidence area renovation began on January 6; and we are creating project drawings and specs for the District Attorney's Juvenile Intake room remodel. Ongoing Highway projects: Hwy W has bids being opened 2/13, with the goal to begin in March. The Brookside parking lot is scheduled to start in early spring with targeted completion date of the end of October. Both Hwy S and the Hwy F realignment are both on schedule. Hwy KR paving enhancement is complete on the section that the State has done, and our planning is on schedule. For Parks: Gruber Law Offices gave \$6,000 donation to assist with programming special events including the Movie on the Mound at Petrifying Springs, Picnic in the Park, and new weekly concert series at Bristol Woods Park. The rates for the County golf courses will remain the same as last year. The golf courses have decided to begin the staff recruitment early, with some great initial results; and the Parks are doing the same. Pets Golf Course is full for afternoon leagues; Brighton Dale still has some openings, but it is filling up. Upcoming 2020 projects for the division are: The Towers (downtown tower and the tower in Silver Lake Park), the raising of the buildings across the street that we've purchased, and the master planning processes beginning for the Civic Center and the Job Center campuses in February.

Citizen Comments

Daniel Duncan, 3600 93rd St, Pleasant Prairie, expressed concern about the condition of our lakeshore. There have been both public and private areas that have been affected by the erosion due to the extremely high lake levels, which are higher than they have been in decades. This has resulted in public and private beaches, which have sustained significant damage from recent storms, being at risk of further erosion. And many homeowners along the lakeshore are facing hundreds of thousands of dollars in costs to address this situation and either invest in counter measures or cut their losses and sell. If left unresolved, this issue could put the economic strength of the entire county in jeopardy through falling property values and reduce tourism. This problem affects all States in the Great Lakes region, and US representatives in Michigan have already reached out to FEMA to address the damage to their shoreline. Mr. Duncan requested the Kenosha County Board draft a resolution to Senator Tammy Baldwin, Senator Ron Johnson and Congressman Bryan Steil to adopt federal legislation allocating federal aid to address this situation.

Leah Blough, 8355 – 57th Ave, spoke in favor of new legislative maps for Wisconsin following the 2020 US census. The Govenor's proposed Commission would be made up of experts and nonpartisan redistricting members from communities of interest and residents from each of the State's eight congressional districts.

Jodi Muerhoff, 7220 – 1st Ave, spoke in favor of the redistricting referendum, encouraging the Board to allow voters to have their say on the ballot in November. Addressing objections raised at the Kenosha County Legislative Committee, Ms. Muerhoff concluded with Wisconsin Attorney General Josh Kaul's determination that maps drawn by a nonpartisan commission would not violate the State constitution, as they would still be presented to legislators for approval.

Amanda Becker, 1807 81st St., spoke in favor of the redistricting referendum, citing a Marquette Law School poll which found that 72% of WI voters want a nonpartisan commission to draw their maps.

Lori Hawkins, 18513 – 102nd Street, Bristol, spoke in favor of the redistricting referendum, warning that the current maps are likely to disenfranchise voters as they will feel their vote does not matter.

Renee Dwyer, 1296 Village Centre Dr., Somers, stated gerrymandering removes choices that voters have a legal right to make. She encouraged the fight for a census in which every person is counted, and a process for drawing district maps that puts the communities first.

Supervisor Reports

Supervisor Elverman gave a report from the Public Works meeting on March 2. Anderson Arts Center held their grand opening on 22nd of February. Everything has been completed there except for some landscaping, and it has been very well received. The ceremonial courtroom scoping project is ongoing, and we are receiving estimates for pursuing grant funding and eventual bidding. The Joint Services Evidence Area renovation construction began on January 6th, and project drawings and specs are being created for the District Attorney Juvenile Intake... with bids scheduled to be released in March. Chiller replacement and facilities at KCC is ready to go. P&D Remodeling is done, and it has streamlined things and made much better use of the space. From Highway Dept, County W has been closed due to the Fox River Flooding, and we were able to put that out for bids quickly. They came in under our estimate, and the work will begin March 9. It will likely be several months before that road is open again. County Hwy C trail project is ongoing. It should be done by mid-July. The favorable weather allowed us to begin early on the Brookside parking lot. The bid was awarded for County Hwy S Phase 1 to Michael's Corporation at just over \$18,000,000, with work to begin this summer. For Phase 2, all of the properties have been acquired for right-of-way. The Highway F realignment project will be advertised on 3/10 for bid opening on 4/14; construction is expected to begin in June or July. There has been some movement on the Highway K project, dealing with drainage and the water issues, and the construction may begin sooner than expected. Parks - FEMA was at all our public properties, and estimates were done. We were a step ahead of everyone as we had the engineering done, and we're actually in the process of getting permits for work on the Kemper shoreline. Our damage assessment estimates by FEMA was \$2.1 million. We are just waiting for the president to authorize public assistance through FEMA to move forward with shoreline and multi-use trail repairs. Other current projects at Kemper include a boiler being replaced in 2020, and we're evaluating windows and tuckpointing on the east side of the building. Oktoberfest, which is held at Old Settlers Park, donated \$10,000 to the Parks Division to work on design for the new band shelter. Golf courses are set to open on March 13, weather permitting. The golf simulator is up and running an doing well. Hiring started early this year and has put us in a much better position than last year.

Supervisor Gentz wanted to thank the board for approving the Joint Services budget each year, and putting public safety as a priority. He reviewed the path for getting the 911 text ready, which was made available to the public on June 25. A letter from the Director of Joint Services was read regarding an incident on June 29, 2020 stating that the text application functioned as designed, and played a significant role in communication and the exchange of information throughout the crisis. The incident lasted about an hour, and concluded safely with no injuries to anyone involved. The Director concluded by saying this was the first significant and protracted event where the test to 911 application was utilized and it functioned flawlessly.

Supervisor Yuhas gave an update on the Pringle Nature Center. Educational programs continue to be well attended. During January, 130 participants attended such events as Home School Science programs, a nature hike, and a popular "Leave No Child Inside: Snow Day." Upcoming events are a Nature Hike "Paws on the Path" on Saturday, March 7th, 10-11 AM (FREE). You can bring your dog on a leash for a hike on the path... also "Maple Syrup Hikes" @ Petrifying Springs on Sat. March 14th and 21st at 10AM and 11:45 AM (FREE)... and "Leave No Child Inside: Egg Drop, Dye & Roll" on Sat. April 11th 10AM-1PM (Public \$8/Friends of Pringle \$6) requires no pre-registration. Whitney Cubal stated it is good that body cameras and budget matters are being discussed by the Board, but pointed out that 2021 is still 5 months away. She expressed concern about the accountability between now and then. She commended the Board for what she hoped to be the first step of many to ensure accountability for law enforcement and implicit biased training.

Kyle Flood, 6208 – 32nd Ave, felt the resolution was watered down and that the rules of order were not observed at the last meeting. He disagreed with Sheriff Beth's comments that a big violent protest occurred on May 31. Mr. Flood stated that whatever happened that night was after the protestors had all gone home, and that it was done by outside people. He further disagreed with other comments made by the Sheriff, as well as his numbers cited in his reports.

Josh Garside Meyer, 11224 – 63rd Ave, affirmed the previous comments made and stated that while Sheriff Beth stated at Thursday's meeting that he receives many thank you letters, Mr. Meyer encouraged the Board to consider the people who are present at the meeting representing a different view.

Diamond Hartwell expressed that this resolution should have been passed in 2016. She further noted the lack of racial diversity on the Board. She thanked Supervisor Gentz from her district for being willing to ask hard questions in the process.

Maggie Kent, 2020 - 87th Place, expressed concern over remarks that Sheriff Beth made on January 25, 2018, which she believed were insensitive and damaging to members of the black community. She noted that these comments contribute to systemic racism.

Emily Fair, 7th District, commended the Board for passing the resolution declaring racism a public health crisis, and hoped that it would be a first step. She encouraged them to continue to fight systemic racism and ensure that Kenosha County is a safe and comfortable place to live for all races. She further cited statistics for Covid deaths and infant mortality rates to show that racism exists within the healthcare field.

Devynn Johnson, 6208 32nd Ave, urged the Board that if they believe that all lives matter, to say that black lives matter, and that it needs to be heard. To see improvement in the black community, the Board needs to serve all members of the community.

Brian Little, 5116 Pershing Blvd, stated that when the Sheriff, who is at the top of the department makes these types of comments about black people, it is scary. It instills fear.

Koerri Washington, Kenosha resident, questioned if any IT expert was present to answer potential questions about technology. He believed it was unwise to address any potential technological issues

without an expert present, and stated it was disheartening to not have members of the Board research the IT issues.

Dionisse, District 11, reminded the Board of their honor and privilege in representing the citizens of Kenosha County. She encouraged them to remember that their job is to help everyone and better the community; and that can be done by prioritizing putting body camera into the upcoming budget.

Stephanie Krezz, 5944 3rd Ave explained the increased response from the community's young people is due to what is being observed by them in the police force. She believes body cameras are a really good place to start, but feels it is important to further closely examine the structure of the police department.

Laurie Hawkins, Bristol, (by email) stated during the earlier precautions for Covid-19, the curve was indeed flattened. Yet, as restrictions are abandoned, cases are on the rise. She requested putting on the record where each Supervisor stands on protecting its residents from Covid-19 and asked that the Board put protections in place regardless of whether the State does or not.

Supervisor Grady reported on the Public Works Meeting. Golf continues to have a good turnout and excellent weather. Brightondale has some drainage work being done. For facilities, \$182,000 was the low bid for a heat pump replacement at KCAB. There is a \$200,000 project for exterior sealant for the Public Safety Building. The restoration of the Anderson Arts Center is near completion. The Ceremonial Courtroom project is ongoing and anyone who want to see the project can tour it through the end of July. There are many ongoing Highway projects. County S Phase 2 (County H to I-94) project has been awarded to the same contractor that was doing Phase 1. A roundabout at County Y and County A is scheduled to begin next season. Hwy 45 – Hwy 142 to Hwy 11 is nearly complete, but the next section of Hwy 142 to Hwy 50 is underway. Completed projects include County E trail project and Brookside parking lot. County KR from County H to I-94 is nearly complete, but from CTH H to Hwy 31 is in the beginning phase including ongoing land acquisition. Kemper Center learned that FEMA declared them ineligible to receive Federal funding for the shoreline damage, so the project will have to proceed without that funding. Pike River restoration is underway.

The **Regular County Board Meeting** was called to order by Chairman O'Day at 7:30 p.m., at the Kenosha County Job Center located at 8600 Sheridan Road.

Citizen Comments

Veronica King, 5518 – 34th Ave, spoke asking the Board to adopt Resolution #21 tonight to help to address the racial disparities. Ms. King brought charts that showed the adverse disparities experienced by African Americans, which include: employment, wealth, education, home ownership, health care, and incarceration. She noted these disparities exist locally, as well as at the state and national level.

Carolyn Feldt, 3807 Van Buren Rd, works for the Aging & Disability Center and attended along with her colleague Andrea Taylor on behalf of the Cultural Respect Builders Committee. The spoke endorsing Resolution #21, which supports their staff efforts toward optimal health for all Kenosha Co. residents.

Leah Blough, 8355 57th Ave, commended the committee for passing Resolution #21 for it to come to the Board floor, but was troubled that not all supervisors concur that systemic racism exists. She asked the Board to support this resolution as a first step toward meaningful changes toward racial equity.

Stephanie Knezz, 5944 – 3rd Ave. stated the question should be "How" and not "If" systemic racism is prevalent in American institutions and therefore in our community.

Joel Trudell, 7850 – 34th Ave, urged the Board to pass Resolution #21. He suggested the ideas we have about what people look like are unconscious biases that must be overcome. The first step is to acknowledge they exist. Voting to pass Resolution#21 is a step on the path to overcoming it.

Whitney Cabal, Kenosha, relayed stories she heard as she went door-to-door in some 'rougher neighborhoods.' These residents are without close access to pharmacy or food stores, and often without transportation. Systematic oppression is present when every resident does not have access to the same services, and it is especially heartbreaking when they have an emergency in the middle of the night.

Rick Gallo, 8036 – 18th Ave, (via email) wrote supporting Resolution #21. He disagreed with the dissenting Supervisors at Committee level and urged the other Board members to support it. Regarding Resolution #22, he felt there was no need to place a referendum on the ballot in November designating WI as a 2nd Amendment Sanctuary State, and that it would be a waste of time and County resources.

Jodi Muerhoff, 7220 – 1st Ave, (via email) stated a 'Yes' vote on Resolution #21 would show that County government is committing itself to make meaningful changes to prove that Black Lives Matter in Kenosha County. She urged them to vote 'No' on Resolution #22 as the right to keep and bear arms is already enshrined in the Constitution, and a non-binding ballot resolution will do nothing to bolster that.

Casimir Rodriguez, Pleasant Prairie, (via email) noted that he does not support Resolution #22 because it is too broad and does not define exactly what it proports to do. This constitutional right is not under immediate attack and does not require protection; further the referendum would have no authority.

Debbie Wrobel, Kenosha, does not support Resolution #22 for the referendum on the November ballot. In such turbulent, anxiety ridden, and chaotic times, it would not be appropriate to encourage even larger gun volume and citizen use.

Kenosha Co. Democratic Party (via email) wrote in support of Resolution #21, which acknowledges there is work to be done in order to achieve racial equity. The time is right to move toward a better Kenosha County for our Black community members.

Adelene Greene, 6730 – 111th Ave, retired Director of Workforce Development, (via email) urged the full Co. Board to endorse Resolution #21 as a starting place to acknowledge the problem of systemic racism, and to develop action steps that begin to address the worsening disparities for people of color in Kenosha.

Atifa Robinson, LIHF Community Strategist and long-time Kenosha resident (via email) expressed concern about the recent discussions regarding Resolution #21 and hope that the Kenosha County Board would consider her request to work together with community partners and the LIHF to develop a three-year plan that will promote health equity for all races within Kenosha County.

Supervisor Gaschke gave an update on his District #7. Last week UW Extension had a food drive which served 400 in the uptown neighborhood and families from surrounding areas. Many thanks to UW Extension and other community partners and volunteers for making this an overwhelming success.

A second matter that is concerning is the upcoming 2020 Census participation. Sadly, the neighborhoods who would likely benefit the most from being counted are the least likely to participate. Based upon the latest info, track #11 in the heart of his district has about a 40% participation rate. This is tragic because being counted now helps set the stage for the next 10 years. Hundreds of billions of dollars in Federal and State funds that are allocated to different communities and neighborhood including: 911 emergency system, health providers & hospital care systems, highways and roads, school lunch program, etc. are all based on being counted. He urged not only the residents in his district but in all of Kenosha County to participate in the census in order to set the stage for success in the next 10 years.

Supervisor Nudo reported that the Public Works meeting on 7/20 had an item on the agenda was a letter to Finance to redirect an overflow funds of about \$70,000 which came from the purchase of a truck that came in approximately 20% lower than projected. In just the last month in the Public Works department, It was estimated there was about a 15-20% overall savings as projected and passed in their 2020 budget. He hopes the Finance Department will ask questions, since the savings of money could be used for other needs such as bodycams.

Announcements Of The Chairman

Chairman O'Day explained that Committee of the Whole meetings have typically been used for the receipt of information on a topic that may affect future actions. This meeting is designed to allow Supervisors to express their thoughts on moving forward to assist in the rebuilding and healing of the Community. No action will be taken at tonight's meeting, but the results of the discussion may form the basis for action in the near future. As this is not a regular meeting of the County Board or its committees, there will be no citizen comments. Any citizens wishing to speak are instructed to plan to attend the next regularly scheduled County Board meeting on September 15, 2020.

Major General Paul Knapp, Adjunct General of the National Guard provided a briefing on the process of how the National Guard is mobilized and how it worked in a supporting role in Kenosha during the recent civil unrest. He provided a timeline of events from the evening of August 23 through the present. He closed by saying they are continuing to monitor the situation and are mindful of key upcoming dates and stand prepared to support Kenosha as well as other Counties throughout the State if they are needed again in this role. He stated the current cost estimate for the National Guard during the unrest is \$5.3 Million.

Supervisor Rose recognized the current issue as likely the biggest crisis in the history of Kenosha County. He expressed hope that after the upcoming discussion, that a resolution would be brought before the board next week to give direction and purpose to the coming weeks, months and years ahead. He welcomed input in the drafting and encouraged non-partisan unity among the Board, with the goal of working in the best interest of all who live in Kenosha. He relayed details of his discussion with the VP of KABA, Heather Wessling, who is developing a list of the approximately 100 businesses who have been harmed, with perhaps 40 of them who likely will not be returning. The estimated cost is \$50,000,000. We want to encourage these business owners to rebuild and support them as they do; while asking the Federal and State governments for funding.

Supervisor Rodriguez read public concerns about the possibility of violence against our city after the election, as well as the upcoming charging decisions... and the importance of having a plan in place. They noted the purchase of bodycams is important but will not solve all of the issues. Speaking for himself, he expressed thanks for the recent updates provided by the County Executive's Chief of Staff, as well as members of the public who were calling out people who were inciting violence and assaulting Police Officers. He stated he looks forward to working together with everyone as the rebuilding begins.

Supervisor Pomaville emphasized that changing the laws will not be the only solution. She addressed the misconception that enacting a few laws will bring about change and move us in a better direction.

Change comes from changing thoughts and minds and hearts, including taking a hard look at ourselves. She questioned whether diversity training would be needed to bring about lasting change.

Supervisor Boyd Frederick recommended the Board to go downtown and spend their money to show support and help them. He further recommended listening to the other voices in the community.

Supervisor Gulley brought attention to the lives that were lost during this crisis and noted that recovery and rebuilding cannot be done on a foundation that does not include equality and inclusion.

Supervisor Gentz questioned how the President's promised \$4 million to rebuilding and \$1 to law enforcement will be allocated. He also offered the idea of creating a TID district with the City for the areas that were burned... so that they would not have to pay taxes for a period of time. He also proposed a committee to look at exactly what the damage was and how to go about asking the State and Federal government for help for them to restore their businesses.

Supervisor Belsky challenged everyone to remember the uptown businesses that were burned, and make sure they are not overlooked in the process of addressing the needs of the downtown areas.

Supervisor Berg highlighted the need to address underlying issues of criminal justice, which includes the courts, D.A.'s Office, and the Dept. of Corrections, in addition to law enforcement. He encouraged them to examine what services we are providing to our black communities, such as mental health services, and dealing with slumlords in Kenosha. He called on the Board to include building up the communities as well as rebuilding the businesses that were lost.

Supervisor Gashke noted that the destruction in his District #7 was devastating; but that the effects on the people of his district is equally important. He reminded his fellow Supervisors that while they are working on rebuilding the property damage, they need to remember that their districts, their community, and their nation truly need to be a place where there is liberty and justice for all.

Chairman O'Day informed Supervisor Rose that the proposed resolution would be put on the Executive Committee's agenda which will be meeting before the 9/15 County Board meeting. Upon Supervisor Gentz's recommendation, once said resolution is brought to the County Board floor, it will be referred to the individual committees.

She spoke to the proposed resolution, which she noted addressed the damage, but ignored the duty, breech and causation of the unrest. She urged it to be rewritten with the input of local black leaders.

Diamond Hartwell, 3rd Dist., reminded the Board that it is not necessary to agree on all issues, but expects decency by all. She believes a lot of the members are decent but are falling short due to their silence on important issues and specifically not addressing the racism shown by Supv. Decker. She also pointed out that a posted mask mandate on a County Building should be observed by all.

Mary Magdalene Moser, 11th Dist., wanted to know why no arrests were made for rioting, arson or looting during the first 3 nights, despite the damage being inflicted. She questioned who gave the stand down order to the KPD, KSD and KFD and why? The citizens deserve answers.

Billy Violet (Whitney), Stated priority was given to downtown, while ignoring uptown. No changes will happen unless conversations are had with the black community. Challenged the Board to get out to the community and get involved and learn to how deescalate. Citizen comments matter.

Justin Blake, uncle of Jacob Blake, reminded the Board that they need to step back and consider the humanity of his nephew. He reminded them that their job is safety for the people. He noted changes need to be made to the laws that will protect the black community.

Kyle Flood, 11th Dist., doesn't believe the resolution as written addresses the issues. He challenged the Board to not remain silent, but to speak out during meetings. He suggested writing a resolution stating that teargas and rubber bullets would never again be used in Kenosha County.

Angela Wojtak, 5th Dist., stated she has seen both sides of this issue. She sustained injuries during an incident involving an excessive response by police. But she also received support during a severe domestic violence relationship. She does not hold all cops accountable for the actions of a bad one.

Pamela Mundling, 3rd Dist., lives in the downtown/uptown area. She wanted to thank the Supervisors who reached out to express the need for extra help in the form of the National Guard during our time of need.

Veronica King expressed concern regarding the posting of face masks required, and yet noted there were 6 supervisors without masks. She also noted there were 5 deputies present and wondered why they were not enforcing this requirement.

Nicholas Dennis, 9th Dist., stated it was whites who burned the city. A group of blacks is not trouble. Expressed disapproval of Supervisor's Berg's social media post the previous night.

LaRon Franklin, 7th Dist., called out those not wearing masks and stated it shows they do not value their positions. He stated it is not only the Police that need to change, but also the Board. He stated that the resolution drafted by Supv. Rose cannot address the problem, when no one from the community was consulted.

Isaac Wallner, Racine, born and raised in Kenosha, challenged the Board to address anyone who shows disrespect by having their back to the citizens while they are speaking. He also pointed out that the Board expects the Community to follow laws and policies, but they are not doing this themselves when they refuse to wear masks. He challenged them to stand up to racism on the Board.

Djuan Wash, one of the founders of (BLAK) Black Lives Activist Kenosha, came from the KPD where Ramon Tidwell was beat up and then let go. He expressed frustration that the approximately 2,000 non-violent protestors were met with tear gas. He stated that it was the police that escalated the situation.

Tyronne Payton, 2nd Dist., noted that there are no African American Board members. He appreciates the Board members who have reached out to have conversations. The Board needs to take the members of the community seriously and take action that resolves the people of color being treated unfairly.

Clyde McLemore, Kenosha, founder of BLM Lake County Chapter. Stated this problem did not start with Jacob Blake getting shot. He stated they organized a non-violent march, and when the curfew was implemented, he encouraged the women and children to go home. He is demanding justice and called out the Sheriff for lying on TV.

Varnell Patterson, 7th Dist. and cofounder of UBMW, (United Brown/Black Men & Women), stated the Courthouse should not have been used as a fortress. Systemic racism needs to be addressed, and we need to work at building race relations in our community.

Emily Fair, 7th Dist., spoke against the citizens not being able to comment at the Executive Committee. Noted the need for committees that create policies that address systemic racism. Pointed out that protestors and rioters are two different things. Highlighted the need for mental health help for all individuals, especially youth, not just the ones deemed problematic.

Madison Taft, Kenosha, concluded that the Board has learned nothing. She is horrified at her politicians. She believes it was inhumane to use teargas and rubber bullets on the peaceful protests. She feels uptown is being ignored while the focus is on the downtown damage.

Elizabeth Webb, Kenosha, member of UBMW, came to get help from the Board but finds herself too emotional to say what she came for. Her nephew was pulled out of the car he was riding in with his mother. She encouraged the Board to not turn their backs on the community as they are speaking.

Alexandria Benanti, 22nd Dist., indicated Supv. Decker's behavior is disgraceful and should not be allowed on the Board. She noted the lack of presence of the Board at the meetings to help the community, and that it is only the non-profits who are helping. She invited them to participate in "Building our Future" event on Sunday Sept. 20th at Las Margaritas.

Sara Chopp, formerly of Kenosha, but an active member of this community. It is a multi-dimensional issue that needs crosssector and cross-party collaboration using Collective Impact Framework. To allow the needed focus on racial equity, she challenged to begin by asking the community and then help them to get the resources needed to put their plans into action.

Brian Little, 11th Dist., asked another gentleman to speak for him who expressed concern over the Jonathan Massey case, and how different Jonathan and his family were treated when compared to the 17-year-old accused of killing two people. He stated he was an eyewitness to the events, and no one has asked him for a statement, or asked if there could have been another gunman.

Rochelle Anderson Moore, Kenosha, a former social worker for Kenosha County, expressed outrage over Supv. Decker's unwillingness to face the community when they are speaking. She spoke on black history and the plight of black Americans. She addressed the issues of safety and lack of affordable housing.

Dionese, 11th Dist., was disappointment that it has taken so long to gather and discuss issues. The citizens are not heard. She asked the Board to make a strong effort to attend community events and to move toward honesty and transparency. She invited everyone to the Justice for Jacob Blake event on 9/16 from 10am-5pm and engage in conversations.

Lakota Lichwalt, 8th Dist., frequently pulled over by police in his past, had become reclusive to protect himself. Based on current events, he began to go out to film, and the danger he perceived was from law enforcement. He encouraged the community to get out and vote to address the disrespect of certain Board members.

Devynn Johnson, 11th Dist., due to lack of bodycams there is no accountability for police, and they are hurting the black community. She told the Board they are failing the black community.

Katy Wallner, Kenosha (via email) a former 8-year member of the National Guard. As a bi-racial American, she spoke of the lack of accountability within the judicial system. She would like to see more mental health services offered to both those incarcerated, as well as those in the foster system. People should be listened to and not be afraid or embarrassed to ask for help. We should be looking for the problems of injustice and not at skin color.

Karen Kempinen, Kenosha (via email) expressed concern in the proposed resolution regarding the contract with a training and development company. She specifically cited food deserts and broadband inequity. She said we should ask for specific short-term objectives, with input from the Black community, and ensure a public report is given on the progress.

Supervisor Reports

Supervisor Grady gave an update on the Hwy. Dept. RR Crossing at Cty Hwy L is rough and is in process of being addressed. Cty Hwy S - Phase 1 will be mostly complete this fall. Cty Hwy H to the frontage road is ongoing. The realignment of Cty Hwy F. Cty Hwy K is basically finished. The bike wayfinding project has been put on hold to address the safety and appropriateness of the locations of the signs. Supervisors Nordigian, Pomaville, and Wienke have been in contact with the municipalities involved. A roundabout at Cty Hwy Y and Cty Hwy A will begin in 2021. The section of Cty Hwy KR (CTH H to STH 31) is projected to be ongoing into 2022. Hwy 45 is basically done. In the Village of Somers STH 32 storm sewer project has had a few setbacks due to soil conditions. Facilities update for KCAB Heat Pump replacement should finish in mid-October. Public Safety Building exterior sealant project should finish up next month. The DA's office and Juvenile Intake renovation will be starting soon. Job Center windows are being assessed for water infiltration and repair estimate. Parks Dept., golf was excellent in due to good weather.

Supervisor Berg reported on the Legislative Committee meeting. Senator Wanggaard and State Representative Kerkman were in attendance. PACT Bill coming forward, which addresses cleaning up Statutes for law enforcement, and using NTSB model for use of force in loss of life. Medical Marijuana Bill AB750 will be coming forward. There is a potential for federal

funding for body cams. Unemployment still has residents waiting since June for their unemployment. With respect to the reconstruction of Kenosha, there is presently no funding available yet due to the need for a bigger picture of the insurance issue.

Supervisor Gaschke thanked everyone who spoke during citizen comments and assured them their voices need to be heard to allow for healing and moving forward. The Planning & Development Committee reviewed a conditional use permit for Kenosha Beef for the expansion of the existing facility and another for more creative outdoor dining options for Sit 'n Bull in the Town of Wheatland both passed through committee and will be coming before the Board in the future.

Supervisor Ron Frederick requested for the Public Works information regarding road construction be made available to the Board in writing form so they can have it for reference for potential questions from constituents.

Supervisor Rodriguez gave a report and provided a copy of the email from the findings of Atty Kreye, from the Legislative Reference Bureau with respect to whether it was appropriate to call a meeting to address the protests and rioting. Atty Kreye cited Wis. Stats. Ch. 19 with what could constitute a 2 hr notice, but emphasized the Board has discretion to determine whether it has good cause for less than 24 hours' notice, but in no case may be posted less than 2 hrs prior. Supv. Rodriguez also pointed out that Sept. 15-Oct. 15 is Hispanic Heritage Month in the U.S. which recognizes and celebrates the contributions of Hispanic Americans have made to American society and culture.

At this time Supervisor Berg was excused from the meeting.

Citizen Comments

Pamela Mundling 7327- 11th Ave, Kenosha, reminded those attending that the Board cannot fire any Elected Official, but they may only be recalled by the electorate; nor can they discipline police officers that are under the authority of the City of Kenosha. She expressed hope that all sides will work together for change in an orderly fashion.

Billy Violet (Whitney), lives on the south side, expressed a commitment to productive communication at Board Meetings. She stated concern over aspects of the County Executive's proposed budget, namely the food deserts that exist which are not being addressed until 2022. Ms. Cabal was thankful that the voices of the community seem as though they are being heard. She reminded them that the citizens are relying on each of them to make our community better.

Diamond Hartwell, 3rd Dist., wanted to clarify a recent Kenosha News article that stated the silence of the County Board that is unacceptable. She pointed out that this is not while they are listening during Citizen Comments, but rather when something blatantly wrong happens in the community or on the Board and they don't do anything about it. It is their actions and how they deal with these things that is a problem.

Emily Fair, 7th Dist., stated that much of the County Executive's proposed budget was foundational. She noted the lack of actual social changes and new programs for people affected by racism. Further, that while rebuilding Uptown is important, she warned against raising the prices which would result in driving the residents from the area. She asked for this budget to focus on what really matters i.e. mental health, health care, schools, small business, etc. instead of spending money on roads.

Calana Hutchinson, District 12, wanted to clarify the Governor's existing mask mandate. Individuals with medical mandates that prevent them from wearing masks do not have to provide documentation as proof. Also, approaching people not wearing masks is not recommended, nor is harassing them.

Joe Clark, 4862 105th Place, Pleasant Prairie, encouraged the Board to listen and show respect when the citizens are speaking. He also pointed out the citizens need to show respect for the forum of the Board meetings. He stated the Chairman should address Supervisors that are called out of order yet continue to speak and not acknowledge the chair. He reminded the Board they are policy makers. With the budget and with the focus on the Uptown area, they need to bring more jobs to the uptown area which represent the diversity of our community.

Joy Aselson, (via email) expressed concern that an email directed to the City Council ended up being sent to a County Board Supervisor, who responded to her email. She was upset and intimidated by the response and wants to know how this happened. She also asked that the Supervisor be held accountable for his reply.

Dionisse (via email), a long term 11th District resident, asked for the budget to prioritize adding funds for addressing the homeless in our community.

Announcements of the Chair

Chairman O'Day spoke to both the Board members and the public, reminding them that respect for other Supervisors and respect for the public is a hallmark of public service. While these have been challenging times, we must commit to courtesy to one another.

Supervisor Reports

Supervisor Grady gave an update on the Highway Dept. Two miles of asphalt paving from Cty Hwy B to the State line CTH C, and then from CTH D to State Hwy 50 and CTH K, was completed, CTH S (Hwy 142) Phase 1 is still scheduled for completion this fall. Phase 2 started the first week of September and is scheduled to go through the entire winter. CTH F is still being realigned and is moving along on schedule. It will tie in with the Kenosha County Veterans Park as a western entrance. The Wayfinding Sign Project has been shelved due to some of the higher speed traffic areas are not appropriate for safe bicycle riding. It has been referred back to the Committee. CTH Y and CTH A had a four way stopped that was removed after the construction on Hwy 32 was completed. Surprisingly, as a result of a change in traffic patterns, accidents have increased due also to people expecting there to be a stop sign there. The Village of Somers has requested another look and perhaps the four way stop to return, until next year in 2021 when a roundabout will be constructed. CTH KR has some lane closures due to the construction of viaducts. Construction on State Hwy 50 is scheduled to begin in February 2021, and to wrap up in fall of 2022. For facilities, KCAB has heat pump replacements are about 1/3 completed. While working on the Public Safety Building exterior sealant project, it was discovered that some glass block panels there have been leaking. They are now addressing that issue with an expected cost of \$50,000. The DA's office and Juvenile Intake renovation will be starting soon, with some more security added to the D.A.'s office to make it more secure. Job Center windows were assessed for water infiltration and it was discovered that the damage that occurred was not as serious as was thought. Parks Dept., Veteran's Memorial Park's restroom facility is nearly complete. The Pike Trails in Petrifying Springs have been substantially upgraded and the community has responded favorably. Silver Lake Beach Park was selected by Bryce Sekey for his Eagle Scout project. He constructed a new shelter located at the top of the beach hillside. Golf had a very productive season, and generated the revenue required for their projects next season. and should not need bonding or levy money. During the winter, they will offer the golf simulator which they have acquired. Public Works Director, Ray Arbet concluded the meeting by stating that there is a search underway in the Uptown area to move the Human Services Building closer to the population that needs its services.

Supervisor Celebre directed the other Supervisors to a handout he provided on the Newsweek ranking of nursing homes. As a member of the Brookside Board of Trustees, he pointed out that Brookside was ranked 3rd in Wisconsin for the year 2021. This represents a move up from 2020. He recognized the administration and the entire staff for their high standards, and who have contributed to keeping it efficient and organized.

Citizen Comments

Ollie Nelson, 7225 150th Ave, spoke as a veteran and concerned citizen. He thanked the Board for voting to support Veterans Memorial Park. With an average of 22 veterans lost each day to suicide, this park will be therapeutic and an opportunity for veterans can reconnect with life.

Porche Bennett Bay, District 7, expressed concern on the initial voting on the bodycams. She did not understand why the resolution did not pass. She also pointed out p. 42 in the proposal for 2021 which gives the goals and objectives for the Sheriff's Dept.; she does not feel like they provide safety and protection for all.

Kyle Flood, 6208 – 32nd Ave, described moving citizen comments to after the vote on two items on the agenda as bad government.

Varnell Patterson, 7th District, thanked the veterans who have served our community. He spoke in support of bodycams and used a Waukegan officer involved shooting as an example. He stated bodycams allowed for transparency and a resolution within 24-36 hours.

James, a resident and law enforcement officer in IL, spoke in support of bodycams, which can help provide unity in the community and prevent rioting and looting. He stated they keep people in check and allows transparency.

Maggie Kent Flesh, 87th St., thanked the Board for passing the resolution but said it should have passed at the last meeting.

Elizabeth Webb, District 7, was offended that the resolution which funded the bodycams did not pass last meeting. She stated it showed disrespect for the members of the community, and disregard for their safety.

Diamond Hartwell, 3rd District, was also offended and irritated at the moving of citizen comments. She pointed out that veterans came because something affected them, but citizen comments were moved to after that vote, which silenced them.

Isaac Waller, lives out of Kenosha County, stated the public has a right to express their opinions before the vote happens. He said it was appalling to not listen and said it was divisive. He encouraged the Board to truly listen during the citizen comments.

Jason Lopez, Kenosha resident, gave a list of demands that represented what he felt necessary for justice for the community.

A Kenosha resident who did not want to give his name told of stories he has heard from children in the community who feel like they are bullied by the police. He also spoke of personal experience of unfair treatment by KPD. If bodycams were already in use, these things would not happen. The community is resorting to recording law enforcement contacts with their cell phones.

Billy Violet (Whitney), 9th District, stated that moving citizen comments was a cop out and only increases tensions. She further stated it as disrespectful to veterans, and that they will remember when it is time to vote. She challenged them not try to silence the community in an attempt to get home sooner.

Emily Fair, 7th District, hopes the Board is doing research to see what the true needs are for the community. She challenged them to hold people accountable for the current mask order. She reminded them the people will know you are listening by further policies that address racism.

Joe Clark, 4862 105th Place, sought to clear up the misconception about why citizen comments was moved, and that it was due to a family illness of one of the supervisors. He reminded the public that the 17 supervisors in attendance have supported the bodycams in the police budget.

Madison Taft, Northside of Kenosha, reminded the Board that when the rules are not fair for everyone, it reveals the character of the Board. She stated that while it was good that the body cams passed, it should not have taken this long. Moving citizen comments makes things worse, and it makes people angry.

Devon Johnson asked for a moment of silence for those of those injured and killed in protests this summer.

Kate Trudell asked for transparency when announcing Citizen Comments was moved. The reason given different than the actual reason, which made it sound like you were trying to silence the citizens. Be transparent and tell the pubic what is happening instead of what you think they want to hear.
