- Improve pavement condition by milling and resurfacing the existing roadway
- Detain and treat the storm water runoff prior to the adjacent lakes.


## **PROJECT LIMITS**

- Construction completion scheduled for June 2023
- County Highway EM will remain open to local traffic during the project. Access to businesses and residences will be maintained. With cautious travel in the construction zone.


