

Contribution Limits for Local Elected Offices

THESE LIMITS APPLY TO ALL CANDIDATES AND PERSONAL CAMPAIGN COMMITTEES.

Contribution limitations apply to the entire primary and election campaign in which the candidate participates, whether or not there is a contested primary election.

<u>EXEMPT STATUS</u> Committees may be eligible for an exemption from filing campaign finance reports if campaign finance activity is low enough to meet the following criteria: THE COMMITTEE ANTICIPATES THAT IT WILL NOT ACCEPT CONTRIBUTIONS, <u>OR</u> MAKE DISBURSEMENTS, INCUR LOANS AND OTHER OBLIGATIONS IN AN AGGREGATE AMOUNT EXCEEDING \$2,500.00 IN A CALENDAR YEAR. January 1, 2024 begins a new calendar year.

Party committees are separate category from political action committees, there is no limit on the amount they can contribution to candidates. Party committees can give unlimited amounts even to non-partisan candidates.
