Candidates,

Get ready for the 2024 Spring Election! The first day for 2024 Spring Election County Board Supervisor Candidates to begin circulating nomination papers is December 1, 2023.

**Please review the information in this packet as there have been a few changes from previous years.**

Use only updated forms for filing your candidate documents. A blank copy of each form has been included in this packet. You may visit the Wisconsin Elections Commission and Wisconsin Ethics Commission websites for their respective form fill documents.

Be consistent with the name you use on each of the filing documents. Refer to the included examples.

On nomination papers, many electors will complete their mailing address when it **must** be their voting municipality. Each candidate or circulator should review each signature for accuracy prior to filing.

If a candidate intends to spend or receive money for their campaign (even their own money) they **MUST** have a CF-1 for the 2024 Spring Election on file with the County Clerk. The CF-1 form may be filed at any time prior to the deadline. Candidates are responsible for their own reports and to follow the Campaign Finance Report Schedule included in this packet.

Candidates may file their campaign documents at any time. The last day to file all required campaign documents is no later than 5:00 p.m., Tuesday, January 2, 2024, with the County Clerk.
