Chairman Nudo welcomed Youth In Governance members Eric La Mere (Human Services Committee) and Erika Bando (Human Services Committee).

The Brookside Board Of Trustees meeting was held on Tuesday, January 3, 2023. The 600 wing is open, and eight beds are filled. The RN positions are filled. There are 27 resident referrals. There will be a loss for this year, but it will be much less than projected due to additional funds from Medicaid. Supervisors were asked to clear their desks of any personal items to prepare for an upcoming trial and the use of the Chambers for the jury selection process.

Reported Pam Larson is the new UW Extension Area Director. She is formally apart of the Y.I.G. program in Racine County, and has held administrative education positions. The Committee met with Atifa Robinson, Nutrition Education Administrator, and learned updates on the Food-Wise program and other nutritional programs and trainings. The Youth As Resources (Y.A.R.) gave six \$800 grants to local youth-led non-profit programs and initiatives. Youth In Governance (Y.I.G.) nominations are open; any community member can submit a nomination. The new 4-H educator has several projects and is continuing to visit various clubs and meetings to network with leaders, volunteers, and participants. Mary Metten, Health & Well-Being Educator, presented updates on educational opportunities with the Kenosha Corrections Center such as re-entry support for job placement and money management; community-wide opportunities include stress management and mental health training. Metten will be working with coaches and staff at UW-Parkside.

Supervisor Bashaw

Reported the Pringle Nature Center Board provided its impact report activity for December; approximately 1,000 people visited. There was a holiday gnome hunt with over 400 hundred participants. There will be upcoming snowshoe hikes and events hosted by the Kenosha Running Company. Bashaw encourages all to enjoy the area.

Reported the Human Services Committee met with Director Jen Freiheit. Director Freiheit reported on the SAMSA grant used to fight the opioid epidemic. Narcan and training has been provided to emergency personnel and any interested residents to increase community members that can help if needed.

Supervisor Gaschke

Reported the UW-Extension presented "2022 Highlights & 2023 Plans". Approximately 800 residents utilized the plant health advising program, 450 residents utilized the community development program, and 566 youth enrolled in the 4-H program. The food wise program had about 2,400 direct contacts and 13,000 indirect contacts. Approximately 5,890 educational contacts worked with various educational programs. The Youth In Governance (YIG) and Youth as Resources (YAR) program is accepting nominations and applications – deadline is February 10, 2023. The Planning, Development, & Extension Education Committee adopted a new fee schedule with some fees increasing and some decreasing (attached per Supervisor Rodriguez's request). The Racial & Ethnic Equity Commission has two vacancies. The County Executive's office completed the first round of interviews – there were ten applicants. They will announce potential appointees following the completion of second round interviews. There is a press release with more information.

Chairman Nudo held a moment of silence in honor of Milwaukee police officer, Peter Jerving, whom was killed on duty on the morning of Tuesday, February 7, 2023.

Citizen Comments

Linda Spaulding (3023 25th Street, Kenosha) shared concern with Committee meeting times. They distributed a <u>written summary</u> to each Supervisor. The concern originates from the Judiciary & Law Enforcement Committee following a meeting rescheduled from 6:30 PM to 4:15 PM. They urged the Board to schedule Committee meetings after 6:00 PM.

Announcements Of The Chairperson

Chairman Nudo recommended the Resolution 72 be removed from the agenda and be referred to the Finance/Administration Committee for further review – the recommendation was non-debatable. The Judiciary & Law Enforcement Committee members completed a voice vote. The vote passed (4-2). AYE: Supervisors Bashaw, Franco, Nordigian and Wamboldt. NAY: Supervisors Decker and Rodriguez.

Supervisor Reports

Supervisor Rodriguez

Stated they were unaware of the Chairman's recommendation to remove Resolution 72 from the agenda. The Committee met with Josh Nielsen, Director of Joint Services, following a meeting with the Executive Committee regarding changes in the Joint Services department. Nielsen had informed the Committee changes were underway to establish new processes to ensure recent problems are not reoccurring. The Committee is aware of misconduct in the department throughout the last decade but are unaware of the dollar amount – it is estimated to be in the range of \$10,000+ from statements given to the Walworth County Sheriff's Department. The Committee found Director Nielsen does not have a current plan in place. Supervisor Rodriguez stated if the issues are not addressed they will require a director.

Supervisor Nordigian

Shared a second public informational meeting regarding the Highway W reconstruction was held; it is scheduled to start in 2024, yet the meeting was well attended by local residents. Some requested changes to the plan, at the first public meeting, were made and the residents were more affirming of the current plan. Clement Abongwa, Director of Kenosha County Highways, was available for questioning at both meetings. Supervisor Nordigian noted the first meeting was not as well attended but noted Director Abongwa had corrected this error by noticing the second meeting in a timelier manner to ensure the meeting was well attended - the effort was noticed and recognized the Director's work. Many of the comments made at the meeting were regarding miscommunication from the Sheriff's Department in

previous years and urged the current Sheriff to increase communication efforts with residents in the Western side of the County.

Vice-Chair Decker

Reported they attended the inaugural meeting of the Opioid Settlement Advisory Panel on January 31. 2023, chaired by Carrie Foss, Manager of Behavioral Health. The panel was created by Executive Kerkman to provide input to the Executive's office on potential uses of the funds the County received, and will be receiving, from the opioid settlements. An overview of ways the settlement funds can be used was discussed. The County received 1.75 million dollars in opioid settlement money, and more is expected. The Executive's goal is to use the interest earned on the principal to pay for programs so the funding can continue following initial startup investments. The panel meets monthly at 1:30 PM, on the fourth Tuesday, at the Kenosha County Job Center (Human Services Building), and the next meeting will be held on February 28, 2023. The panel will learn more on the Botvin LifeSkills program and evidencebased substance abuse and violence prevention programs. On February 6, 2023, Vice-Chair Decker joined Executive Kerkman and Nathan Houdek, Commissioner of Insurance for WI, on a tour of the County's flood mitigation efforts which coincided with flood insurance awareness week. The County's participation in the National flood insurance programs community rating system allows for a discount of up to 25% for policyholders living in split special flood hazard areas. Only seventeen units of local government in WI participate in this voluntary community rating system and Kenosha County is one of two in WI, and 170 nationally, to achieve a class five rating. This recognizes the efforts of the County's ongoing fox river floodplain buyout program led by Andy Buehler, Development Director of Planning & Development. Since 1995, the program has obtained FEMA funds to purchase 186 parcels, including 119 residences, located in the floodplain. The voluntary program allows residents to relocate to drier land and reverts the newly county-owned properties to natural land in the floodplain. Supervisor Decker shared several flood insurance facts.

Supervisor Nedweski

Shared the Human Services Committee met on February 7, 2023, and received a Narcan and Fentanyl strip training; County schools have increased training. Overdose emergency kits will be placed in County buildings in the upcoming weeks; the grant may be expanded to allow for further placement in businesses or various organizations through the County. It is recommended that all inquire about attending Narcan training and obtaining an overdose emergency kit.

Chairman Nudo states there will be no County Board meeting on July 5th. The next County Board meeting will be on July 18th.

Supervisor Reports

Supervisor Rodriguez introduced Robert Ayer from Troop 385 in Bristol. He will be interviewing members of the County Board after the meeting.

Supervisor Nedweski stated Governor Tony Evers signed Assembly Bill 245 into law making it 2023 Wisconsin Act 12. This will allow Wisconsin municipalities a minimum of 20 percent increase in shared revenue with many exceeding that number by far. Kenosha will receive an increase of approximately 1.3 million dollars in new municipal aid over last year.

Supervisor Nordigian reminded everyone the next Public Works meeting is Monday June 26th at the Pringle Nature Center starting at 6:30pm. There will also be an open house from 5:30-6:30pm where we will be testing out the new all-terrain wheelchair. The Kenosha County Dairy Breakfast held at the Daniel's farm in Kansasville was very well attended cannot wait to see everyone there next year.

Supervisor Karow states the Planning, Development & Extension Education Committee met two weeks ago in June and had Mary Metton and Stephanie from the Sharing Center present a financial coaching program they are working on. They have had over 80 people referred from the Sharing Center in the last year and it has been a very positive outcome. The Sharing Center helped 120 people with housing in 2022 and have already made it to that level for this year. They are looking to quadruple the number in 2023 from 2022. It has been a challenging few years with the higher cost of living, the ending of the support from COVID relief, and just the higher inflation of expenses. The 2022 UW extension update from Pam is on everyone's desks. Our Youth In Governance Educator, Erica Ness is taking a position in Columbia so we will be looking for a new Positive Youth In Governance Educator in the next couple of months.

Supervisor Thomas discussed the parking issues on the weekends at Petrified Springs Park due to the beer garden. Some parking tickets have been issued but it is something the County Board needs to look at and consider the safety of the people using the park. For the first time since last August there was a

chairperson to start the Racial & Ethnic Equity Commission meeting. The meeting had to be held in the County Board Chambers due to the influx in citizen comments. There was a misunderstanding due to an item placed on the agenda regarding racism being a public health issue. It was put on the agenda due to having six new members on the committee and the need for it to be discussed to have documentation and more guidance for the future.

Supervisor Berg discussed the Juneteenth event in Civic Center Park. The State, County, and City all had proclamations. In addition to Supervisor Thomas's comment, another agenda item was the Jennie Tunkieicz Award for Racial & Ethnic Equity Commission. Typically, the award is given in April but because of all the changes it has been delayed. Prior to the Legislative meeting, Habitat for Humanity dedicated its 6th or 7th house in District 10 and have two more currently being worked on.

Supervisor Yuhas reported Joint Services April activities. An HR Coordinator, Julie Bach, has been hired. In April, 4.855 911 calls were received by the communications department with 95 percent of those answered in under 10 seconds and 98 percent in under 15 seconds. There were 15,329 non-emergency calls handled and 30 911 text messages received. The records clerks entered 323 warrants into the Time System. They recalled 80 Circuit Court and Municipal warrants. They cancelled 173 warrants that were served by law enforcement. Records clerks processed 31 orders of protection. 1,772 cases and supplemental reports were reviewed. While serving citizens at the front counter, records staff took 27 complaints and written reports. They also booked 6 juveniles as well. Regarding Fleet Maintenance, 337 maintenance and repairs were performed. Vehicle manufacture recalls continue to be scheduled as parts are made available for the repairs. Regarding evidence and ID, staff continually receive, process, disseminate and fulfill the data digital media requests the fulfillment of one request may include multiple instances of research, dissemination and follow-up until the request is fulfilled throughout the course of a day. ID technicians can spend anywhere from one to five hours simply receiving, reviewing, disseminating, and following up on duplicating media for and completing requests. In 2018 the average number of requests completed per month was a hundred and four. In 2022 the average number of requests completed per month are 243. Through April of 2023 the average number of requests completed has risen to 260. From 2018 through April of 2023 that's an increase of 148 percent for the average number of requests completed per month so you can see that our requests are increasing. Also, department staff took in 41 boxes of prescription drugs to be turned into the property room for drug takeback day on Saturday, April 22nd. These items were among a total of 129 boxes weighing 1499 pounds released to and disposed of by The Drug Enforcement Administration of April 24th. In the month of April, the ID technicians took in 1810 items, disposed of 732 items. Handled an additional 382 items tracked as evidence that were released to other entities and returned to the property room. Staff transported 27 items to the crime lab and processed 28 pieces of found property. They also made 53 DNA collection appointments, completed 33 ink fingerprint cards, completed 58 bookings, review, and submitted charges for 606 total bookings to the Wisconsin Department of Justice and completed 247 digital media requests.

Supervisor Bashaw wanted to thank everyone who attended the Kenosha County Dairy Breakfast at the Daniel's farm. The Broadband Committee still continuers to meet once a month however still do not have a quorum. There will be a meeting Thursday. The Paddock Lake bandshell dedication was a beautiful event and hope everyone gets the opportunity to enjoy it this summer. Judiciary and Law met on June 7th and will meet again on July 5th. One modification is that the meeting time has changed to 6pm. Michael Babu and Angelina Lagunas were introduced from Youth in Governance and the committee is looking forward to their insight. Last year County Thunder had a limit of 50,000 people to attend and this year it has been reduced to 30,000 due to concerns.

Supervisor Gaschke commended to Kenosha County Parks and Planning staff on their work with the trails, paths, bike routes and events. Last week was Bike to Work Week and last weekend Kenosha County sponsored and organized a Dairy Air Bike Ride which was a 10-mile ride from Silver Lake Beach to the Kenosha County Dairy Breakfast at the Daniel's farm. There was about 50 participants and safety was provided by the Kenosha County Sheriff's Department.

The Opioid Settlement Funds in 2022 we received about \$1.8 million with an additional \$375,000 expected in 2023. With those funds, the County Board has approved a Community Prevention Specialist who will be working with local schools to educate students on drug use and the effects of that.

Supervisor Nordigian reminded everyone the Kenosha County Fair is open Wednesday through Sunday and hopes everyone checks it out.

Supervisor Bashaw states the Paris Solar Project installation has been delayed due to having difficulties getting the solar panels through customs and into the United States. They are hoping to have them by late Fall but will most likely be early Spring.

Supervisor Rodriguez gave an update about the courtroom restoration project, the blue-ribbon committee is overseeing the fundraising and met today. There were some questions about how much money has been provided to the consultants over the last two years. The first consultant group received 84,500 dollars by the end of their contract, which included a feasibility study. That money was needed to apply for the Jeffries Foundation Grant, which Kenosha received, and it is 675,000 dollars, a third of the total project cost. That contract expired mid last year, and they did not renew with that group. Instead, they went with the Abbey Group, who specializes more in the type of project they have here. That decision was made in correlation with the county executive as well as the Blue-Ribbon Committee. The Abbey Group has received 34,000 dollars in consultant fees paid to date and with their contract through June of 2024 with an additional 56,000 dollars. The total amount pledged, not including the Jeffries Grant, so far is 435,602 dollars. The match needing to be raised is 1,350,000 dollars, meaning they are roughly a third of the way done. Since the last meeting over 50,000 dollars has been raised for the courtroom. The deadline for the challenge Grant is June of next year. The funds are being housed and processed by the Kenosha Community Foundation. The money pledge needs to be collected by June 26, 2024. The pledges are either a one-time pledge or a pledge given over three years and the individual, business, or foundation can decide how they divvy it up. Supervisor Rodriguez encouraged the county board member to donate as well.

Supervisor Nedweski thanked Alderman Kennedy and Supervisor Belsky with their involvement in the sister city project and spoke about how the supervisors of the county have an important role in conveying the true spirit of Kenosha County, city and all the municipalities.

Supervisor Nordigian gave an update on Public Works. A full <u>report</u> of all updates has been sent to all supervisors.

Supervisor Bashaw spoke about his weekly call with Paris solar, the solar panels were set to arrive in fall however they are being delayed at U.S. customs and are hoping to arrive in April. I feel that this is appropriate to ensure that there is not even a perception of a conflict of interest. Accordingly, I am advising that I will not engage in any debate related to Kemper and that when I cast my vote in favor of the budget this evening, it includes an abstention on those portions involving appropriations for Kemper, and I ask that the record so reflect".
